PLEASE READ THE FOLLOWING CAWA REGULATIONS CAREFULLY PRIOR TO COMPLETING AND SIGNING THIS EXPORT APPLICATION.

A107 EXPORT OF DOGS

- 107.1 Any person exporting a dog shall be either an Ordinary or Associate Member of the Association and should any person apply to export more than three dogs in any twelve months period he/she shall be registered by the Association as an Exporter. Registration is to be renewed annually at a fee as prescribed by Governing Council from time to time.
- 107.2 A dog must be registered on the Main Register (A5.6.1) prior to export and shall not be exported except by the registered owner thereof except that pups over eleven (11) weeks old may be exported subject to an application for registration having been lodged with the Association. 03/04
- 107.3 An Export Pedigree shall be provided for every registered dog transferred to an overseas owner. The exporter is to complete all detail on the application for transfer and export pedigree. The address of the purchaser is to be the address to which the dog is exported.
- 107.4 It shall be an offence to show an Australian address on a transfer form for a person normally resident outside Australia.
- 107.5 Where a registered owner employs a shipping agent to act on his behalf in the export of any dog the registered owner remains liable to the CAWA that the requirements of Regulations A106 Transfers and A107 Exports are complied with in regard to the transfer and export of that dog.
- 107.6 Where a registered owner is not prepared to be liable for the actions of an export agent, the dog to be exported must be transferred into the export agents name prior to export.
- 107.7 No registered dog shall be exported before it is eleven (11) weeks old. **08/05**
- 107.8 Dogs sold overseas as "pets" and for which documentation is subsequently sought are to be transferred and an export pedigree applied for by the exporter.
- All dogs to be exported must be microchipped prior to export and the microchip number recorded on the Export Pedigree.

PLEASE NOTE:

- 1. The Regulations relating to Exports (A107), as above, are to be adhered to in all details and failure to do so may result in the export being invalid. Should you have any queries please contact the office.
- 2. The original Certificate of Registration, in the applicant's name/s, **MUST** accompany this application, except where the application is submitted attached to a Litter Registration Form.
- 3. It is a breach of the Regulations to sign and hand over blank applications for Transfer or Export.
- 4. Once submitted the information contained herein will become the property of the CAWA and used as determined by the CAWA.
