- a. Completed one (1) Novice and one (1) Advanced judging appointment in each of the four elements to the satisfaction of the Association. One of these appointments must be in the Perth metro area.

AND

Prior to application to judge Excellent and Masters Scent Work Classes, each candidate must officiate as a steward for one (1) Excellent or Masters Interior and two (2) other Excellent or Masters classes in any of the other elements. These assignments to include designing and overseeing the search area and setting of hides, and shadow judging under the direction of the officiating judge.

- b. The maintenance of a list of assignments, complete with exact dates and other relevant details, is the responsibility of each judge. Such detail must be furnished when applying for elevation of status.
- c. For a class to be counted towards elevation of status there must be four (4) or more dogs present.
