# President's Report



As I write this, Christmas is approaching and there remains no indication from the State Government regarding border openings.

I hope that all Members found time to catch up with family and friends during the Festive Season as much as was possible.

### The Bill

The Bill was not brought on by the Government during the final sitting weeks of the Upper House.

Minister Templeman, in a media release the day after the last Upper House sitting day, announced that a re-elected McGowan Government will "prioritise plans to stop the cruel practice of puppy farming and de-muzzling of greyhounds". It will be part of their re-election campaign and the Bill will return should they win government.

The Dogs West Executive is taking informed advice on future steps that may be taken before the State election, and after if the Government is returned for another term.

### State Government Election

At the State Government election in March, we will all vote for the people we consider are best placed to govern our State.

Voting is a democratic right that many people in the world do not have, and should be exercised with serious consideration, particularly in relation to the house of review for an elected government, the Upper House.

If a government holds a strong majority in the Lower House, it is in the Upper House that any proposed Bills are scrutinised and may have amendments tabled and accepted. It is an important function of the Upper House.

When it comes time to vote, please take into consideration those persons and Parties who are supportive of the aims and objectives of Dogs West and our Members.

Being a supporter of Dogs West does not mean that a person or Party supports Puppy Farming.

On the contrary, it demonstrates support for the considered and caring keeping and breeding of dogs that are fit for purpose, whilst maintaining their pure bred breed heritage for future generations.

Dogs West supports welfare for all dogs. Please ask anyone you are considering for your vote for their views on the breeding and protection of pure bred dogs, and all dogs, and how that relates to the Bill that was tabled.

### A New Year

It appears that the uncertain times of the pandemic will continue into 2021 as we live the new normal and await news of an effective, safe and available vaccine.

How these matters will impact on Dogs West, our Members and events going forward remains unclear, but we remain alert and will keep Members informed.

I wish all our Members, their families and friends, a healthy and fulfilling 2021.

## LIFE MEMBERSHIPS & DISTINGUISHED SERVICE AWARDS

Governing Council is calling for nominations for Life Memberships and Distinguished Service Awards and any Awards approved shall be presented at the Annual General Meeting in August 2021.

The Honours Committee will view all submissions and then make a recommendation to Governing Council.

The mandate of the Honours Committee is: -

- To provide a system of Awards to recognise members of the Association who have made a significant contribution to CAWA and its committees and clubs, or to the development of recognised breeds.

### LIFE MEMBERSHIP

Such recommendations shall be based on meritorious service to the Association (Section 8.3 of Constitution).

Nominations for **life membership** are decided primarily on service to the Association. Other service can be included to indicate the overall commitment of the person being nominated.

### DISTINGUISHED SERVICE AWARD

Governing Council may award a maximum of three (3) Distinguished Service Awards in any year to members of the Association.

Eligibility for an Award shall be: -

- Long and distinguished service to the Canine Association and/or its affiliated clubs; and/or
- Service which has significantly advanced the aims of the Association; and/or
- A significant contribution to the development of breeds recognised by the CAWA.
- Such Awards shall not be awarded to a Life Member of the Association, although receipt of an Award shall not debar a member from subsequently receiving Life Membership.

A Distinguished Service Award may be awarded posthumously.

Therefore, in accordance with the above, should you wish to nominate any CAWA Member, to be considered for either a Life Membership or Distinguished Service Award, please forward the nomination and a resume relating to their contribution to the CAWA or an affiliated club, to the Administrative Officer **NO LATER THAN Friday 26 February 2021**.

All nominations are to include detail such as dates so that claims can be verified by the committee.

Recommendations are submitted to the April meeting of Governing Council.

## CORRESPONDENCE

Agility Club of WA – Request for levies to be waived

THAT Dogs West administration levies on entries for the 2 x Agility (Jumping) Trials on 21 November 2020 be waived. As a 'one off' approval, due to the significant financial impact on the club due to cancellation of training and events during the Covid pandemic, and to assist with update of club's equipment transport vehicle.

## GENERAL BUSINESS

'Complimentary membership' to be considered. Possibly to be offered to puppy buyers with limited benefits e.g. digital magazine, use of grounds but not voting rights.

Consideration of DNA proof of parentage for all litters registered. Only required for Main Register puppies. Already in place in Dogs Qld.

Concern re a photographer in the ring at events. Established it should be addressed by the Chief Steward on the day.

A vet cardiologist would be visiting Perth once borders re-opened. Possibility of a presentation for members. To be co-ordinated with Member Education Working Party.

A local liberal candidate had approached Dogs West to support an upcoming fundraiser for his campaign and had sent drafts of flyers indicating he was 'joining with Dogswest to stop puppy farming'.

President to contact candidate to clarify that Dogs West was seeking amendments to the Bill and Dogs West are apolitical.

C Murphy is now a councillor, in accordance with Dogs West Constitution:

- 18.5 - When a casual vacancy occurs as a Councillor, the vacancy shall be offered to the Deputy Councillor who has polled the next highest number of votes from the previous election. The new Councillor shall hold office until the next election.



## SUMMARY OF THE ANKC LTD ANNUAL GENERAL MEETING & BOARD MEETING HELD VIA ZOOM VIDEO CONFERENCING ON 17th OCTOBER, 2020

At the recent Annual General Meeting of the Australian National Kennel Council Limited held via Zoom video conferencing:

### 1. Election of ANKC Ltd Executive

- Mr Brian Parker was elected as Vice President for a one-year term from 17 October 2020; and
- Mr David Sales was re-elected unopposed as Treasurer for a one-year term from 17 October 2020.
- Ms Pamela Campbell was re-elected as a member of the Executive Committee for a one-year term from 17 October 2020.

At the October 2020 ANKC Ltd Board meeting, Directors resolved/considered the following:

### 1. Turkish Shepherd Dog Survey

It was resolved that the status quo is to remain where there will be two breeds with the Anatolian Shepherd Dog using the current Anatolian Shepherd Dog breed standard and the Kangal Shepherd Dog using the FCI Kangal Shepherd Dog breed standard and owners may transfer the affected dogs from one breed to the other up until the 30 June 2021.

### 2. CACIB Shows: 2022-2023

It was resolved the following confirmed expressions of interest to conduct CACIB Shows in 2022-2023 have been approved by ANKC for submission to FCI for their approval:

### 3. Regulations Part 3A to 3N: New Clause to be added

It was resolved that the following clause be inserted into all ANKC Ltd Regulations Part 3A to Part 3N:

*A member wishing to enter any Judges' Training Scheme must apply to the Member Body in their state of residence.*

### 4. Regulations Part 5 – Conformation Shows: Clause 1.1.7 Amendment

It was resolved that Regulations Part 5 – Conformation Shows: Clause 1.1.7 be amended as follows:

1.1.7 *Proprietary Interest – having some legal or equitable interest in an animal on an on-going basis. For the purposes of these Regulations the definition does not include boarding a dog at a Judge's boarding kennel.*

### 5. Regulations Part 5 – Conformation Shows:

#### New Clause 8.1.4 Amendment

It was resolved that Regulations Part 5 – Conformation Shows, Section 8, 8.1 Exhibit be amended by the inclusion of an additional Clause 8.1.4 to read as follows:

8.1.4 *A dog cannot be entered in the name of a deceased person once the administration of that person's estate has been finalised.*

### 6. Regulations Part 5 – Conformation Shows: Clause 3.2.5 Amendment

It was resolved that Regulations Part 5 – Conformation Shows: Clause 3.2.5 be amended as follows:


*"I undertake to abide by the Rules and Regulations of the ANKC Ltd and judge to its approved Breed Standards/Regulations/Rules and any member body regulations applicable to this assignment. I declare all information on this form is correct and if circumstances make the information inaccurate, I undertake to inform the ANKC Ltd forthwith.*

*I also declare I am physically fit and capable of judging in the normally accepted manner. I acknowledge this is a continuing obligation and I undertake to notify the contracting affiliate should my health status impact upon my ability to judge in the normally accepted manner."*

It was resolved for the amended declaration to be included in the Judges' contract and the Non-resident Judges' application form.

## AUSTRALIAN NATIONAL KENNEL COUNCIL LTD

### PRESS RELEASE - TURKISH SHEPHERD DOG SURVEY RESULTS

A survey was conducted by ANKC Ltd earlier this year to ascertain the feedback from any Member of a Canine Control affiliated with the ANKC Ltd and who was the owner of a registered Anatolian Shepherd Dog or Kangal Shepherd Dog to the following questions:

- 1) Do you agree to the renaming from Anatolian Shepherd Dog to Kangal Shepherd Dog?
- 2) Do you agree to the FCI Standard for FCI CACIB shows?
- 3) Do you agree to an Australian Kangal Shepherd Dog Standard for non-CACIB shows?

The response received indicated support.

As this was an amendment to current regulations, the result of the survey was referred to the ANKC Board of Directors for consideration at their October 2020 Special Board meeting where it was resolved that the status quo remain where there will be two breeds with the Anatolian Shepherd Dog using the current Anatolian Shepherd Dog breed standard and the Kangal Shepherd Dog using the FCI Kangal Shepherd Dog breed standard and that owners may transfer the affected dogs from one breed to the other up until the 30 June 2021.

The ANKC urges those owners who want to take advantage of the transfer moratorium to ensure that they are satisfied that the dogs they are moving to the Kangal Shepherd Dog Register comply with the requirements of the Kangal Shepherd Dog Standard.

As a consequence, the following new clause will be added to Regulations Part 6 - The Register & Registration:

- 6.2.4.9 Anatolian Shepherd Dog/Kangal Shepherd Dog  
The status quo will remain where there will be two breeds with the Anatolian Shepherd Dog using the current Anatolian Shepherd Dog breed standard and the Kangal Shepherd Dog using the FCI Kangal Shepherd Dog breed standard. Owners may transfer the affected dogs from one breed to the other up until the 30 June 2021.

# In Memoriam PAUL WILKES 18 February 1955 – 8 October 2020

The passing of Paul Wilkes is an immeasurable loss to Dogs West and the dog world of Western Australia. Paul was dedicated to the progress of Dogs West – its affiliates and its activities, particularly conformation.

Over many years he was always a contributor to the sport that he embraced through his participation with affiliates, in the administration of Dogs West and fund raising events.

Paul and his family came into the dog world in 1966 with their Australian Silky Terrier that Paul handled in the show ring. From then they were hooked and Paul's interest in his chosen sport progressed from there to be a lifetime commitment.

Whist still in short pants, Paul had begun stewarding under the guidance of our mentor the late Wray Minors – the Vice President of the Association.

In 1970, a group of junior members – and there were quite a few of us in those days – decided to form The Junior Kennel Club of WA and with the encouragement of Wray Minors and Claude Wilkes this happened in 1971 with affiliation in November 1974. Paul was the President, Myra Thomas was secretary and I was the treasurer – had to be over 21 years old for bank purposes in those days and Paul wasn't old enough, with Pauline Anderson (now Scari), Allan Thomas, Doug Taylor and Robbie Chisholm being some of the committee.

After showing a few different breeds – owned a Schipperke and a Pointer along with helping other exhibitors – Paul obtained his first American Cocker Spaniel in 1980 which then became his prime breed to concentrate on in showing and breeding. The Staryanks prefix was first registered in 1980 in Paul's name, which later was transferred into Paul and Debbie's name after their marriage.

Paul and Debbie were married in November 1982 with Dr Peter Tallentire – now retired all breeds judge – performing the duties of MC at the wedding. The Wilkes family expanded with the arrival of two sons – David in 1983 and Graham in 1985. When the boys became involved in both cricket and football, Paul took a long break from showing dogs to take the boys to their sport. Never a sporting participant, Paul was still very keen on following sport and supporting the boys – both had gained cricket scholarships to Kent Street Highschool. As expected, Paul became involved in the administration and soon became treasurer of the cricket club, served on the committees of both cricket and football clubs and was often the scorer at the cricket matches.

Paul's involvement in the administration of the Association and with affiliated clubs was commendable.

He was an elected Governing Councillor from 1981 to 1984 – took a break whilst training as a judge – 1989 to 1995 – took a break when the boys were involved in sport – then from 2013 until early 2020 when he was granted leave of absence due to his diagnosis.

In 1988 Paul passed his final exam and was elevated to the status of All Breeds judge – one of the youngest Australians to achieve this honour at the time.

Paul has served on the Association's Finance committee as he was especially interested in progressing the financial wellbeing of the Association and ensuring that the affiliates were cared for when there was a possibility of increased fees, Canine News, Conformation Judges Training committee as a Gundog group convener for several years and over many years as the chairperson of the Canine Fund Raisers working party.

The Fremantle Dog Club benefited from Paul's service as treasurer over many years always with a close eye on the finances, along with being president of the Setter & Spaniel Society.

In 2010 I had the honour of nominating Paul for recognition of his dedication to the Association and he was bestowed with a Distinguished Services award at the 2010 Annual General meeting.

There were many fun times that had Paul as an enthusiastic participant – cricket matches between clubs at the new Canine Association grounds, car rallies for the JKC, progressive dinners, the follies performance at one of Elaine Beck's fund raising events in the early days of owning our grounds.

Paul was a staunch supporter of the conformation clubs through his involvement in PRP Print in providing catalogues for events. In the interest of progressing the office work at shows to be easier for club volunteers, more efficient and to make use of current technology, Paul put in place the computerised programme to issue completed certificates.

The Wilkes family – Paul's mother Shirley, his wife Debbie and sons David and Graham along with their partners Caitlyn and Felicity – our thoughts are with you during this sad time. Nothing can replace Paul in your lives but you hold many enjoyable memories of a devoted family man.

I will miss Paul – both as a friend and as a Governing Councillor - as we go a long way back in our involvement in the dog world. His forward thinking for the benefit of the Association was admirable and his valuable contributions over many years will be long remembered.

## Retirement Appreciation



I wish to extend my appreciation to the members that wished me well for my retirement from my position as Chief Executive Officer, also to the members that have checked up how I am faring as a retiree.

When I was appointed to the position of CEO it was a bonus that I was able to work for the organisation that provided the activities for my chosen hobby of showing and breeding pedigreed dogs. My past administrative positions within the organisation – club secretary, elected councillor

and elected President for several terms – were of great background for the everyday administration in the Dogs West office.

During my seven and a half years in the position of CEO, I had the opportunity to oversee many developmental and upgrade projects that have improved the Dogs West headquarters and activity centre for the benefit of the members. # Heat Stroke

Joanne Bibby - Fursafe®



Heat stroke is a life-threatening condition all Australian dog owners should know about.

Heatstroke is a state of hyperthermia (dangerously high body temperature), a condition in which the body loses the ability to cool down after being exposed to extreme heat.

Dogs eliminate heat by panting and by way of sweat glands in their paw pads, however once a dog is unable to self-regulate, their temperature rises, and their life is threatened.

## Causes of Heat Stroke

### Exertional / Environmental

- Hot weather, especially humid environments;
- Leaving a dog in a hot car;
- Dog left outside without shade or water;
- Excessive exercise/activity on hot days;
- Walking on hot roads;
- Inside rooms without cooling systems; and
- Lack of acclimatisation to hot environments.

### Biological / Medical

- Obesity;
- Large breeds greater than 15kg body weight, e.g. Labradors, Retrievers, Bull dogs;
- Poor physical fitness;
- Exaggerated physical features; Brachycephalic breeds (flat faced), Bull dogs, Pugs; short limbs; excessive skin wrinkling;
- Medical conditions: respiratory; general illness; seizures; dehydration; and

- Puppies / Elderly Dogs

## Prevention

Being aware of what causes heat stroke, provides you with the necessary guidance on how to prevent it.

Some ideas to think about:

- Have multiple water bowls in place in case a bowl is tipped over;
- Ensure your backyard has shade available regardless of the time of day;
- Consider a paddling pool like those half shell pools;
- Give your dog electrolytes as directed on the packaging or recommended by your Vet; and
- Leave your dog inside with the fan or air conditioner running at 23/24°C

## Complications

A dog who suffers heat stroke is at risk of many lifelong health conditions, such as, but not limited to, damage to their:

- Kidneys;
- Lungs;
- Muscles;
- Brain and
- Heart.

In the immediate, however, if heat stroke is not managed urgently a dog may face multiple organ failure followed by death.

Learning how to manage this condition will improve your dog's chances of survival and continued wellbeing.

# Heat Stroke *Continued....*

## Signs & Symptoms

Some of the signs and symptoms which your dog may begin to display are:

- Dog will begin to pant excessively
- Paws will be hot to the touch
- Excessive drooling
- May have become agitated and aggressive
- Experiencing anxiety, distress and disorientation
- Vomiting
- Gums appear dark red, dry and tacky to the touch
- Rapid heart rate:
  - Puppy and Small dog over 160bpm
  - Medium and Large dog over 100bpm
- Rectal temperature over 39.2 °C
- Collapse

*If not treated immediately, dog will go into cardiac arrest*

## Action

1. Undertake Primary Assessment DRSABC
  - a. Check for **Dangers** – a danger may be that the dog has become aggressive (*warning: never put a muzzle on a dog who has breathing difficulties*)
  - b. Is your dog **responding** to your voice or your touch? If not your dog may be unconscious
  - c. **Send for help**; if there is someone else in the house get them to do things like get the heat stress or first aid kit, help carry dog into house, prepare the car and call the Vet. They may also be able to help you restrain your dog
  - d. Check the **airway** for vomit in the mouth, remove if there is
  - e. Check the **breathing** (respirations) feel / watch the rise and fall of the chest – start artificial respiration if not breathing
  - f. Check **circulation** (pulse) – start CPR if no pulse

2. Calm your dog; talk in a soothing way
3. Move your dog into the shade or indoors
4. Check dogs temperature - normal temperature is between 38.5°C and 39.2°C: use a lubricated rectal thermometer inserted into dog's rectum up to 2.5cm for up to 1 minute (or until result registers); record temperature for vet
5. If your dog's temperature is above normal, you must get your dog's temperature down immediately; run cool (NOT ICE COLD) water over your dog's entire body; place a towel or sheet over the dog and wet while on the dog to help with the cooling process
6. Make sure you have airflow over the dog; use a fan or air-conditioner
7. Monitor temperature every 5 minutes

**Warning: do not over-cool your dog as you risk hypothermia.**

**Cease cooling at 39.2 °C.**

8. Treat for shock, elevate dogs rear end, even whilst in the car, keep warm, monitor breathing and heart rate
9. Offer your dog a bowl of water to drink
10. Get to vet
11. If you have a driver:
  12. Continue the cooling process if dog's temperature is still high; use a spray bottle of water or keep wet sheet or towel on the pet
  13. If your dog stops breathing, begin artificial respiration on the way to the vet surgery
  14. If your dog's heart stops beating, begin CPR on the way to the vets

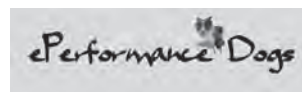

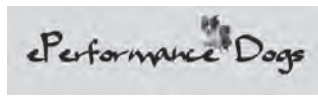

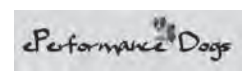

# Code of Ethics MEMBERS' CODE OF ETHICS (latest amendment August 2020)

## SECTION H - CODES OF ETHICS

### HM MEMBERS' CODE OF ETHICS (effective 1 March 2008)

#### HM1 ACKNOWLEDGMENT

Each person, when signing an application for membership or renewal of membership of the Canine Association of Western Australia agrees to the following:

- to be bound by the ANKC Ltd regulations and rules
- to be bound by the Constitution, Rules and Regulations of the Association
- to be bound by the Association's Code of Ethics
- To allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. 04/17

#### HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- 2.2 A member shall not engage in any behaviour that is contrary to the standards accepted by the community.  
Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.

Bullying is defined as repeated inappropriate behaviour direct or indirect, whether verbal, gesture, physical or otherwise, conducted by one person or persons against another person or persons.

This includes, but is not limited to:

Cyber bullying – placing an offensive or hurtful public message, image or statement on a social network site or other public forum where that message, image or statement can be viewed and/or repeated by other people will be regarded as bullying behaviour.

- Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
- Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. (07/15)

- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times.

This includes but is not limited to:

- Littering
- Damage
- Unacceptable behaviour
- Bullying

- 2.4 A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 2.5 A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 2.6 A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. 08/11

- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. 08/11
- 2.8 Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- 2.9 Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
- 2.10 A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code.
  - 2.10.1 During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.
  - 2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. 04/17
- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.  
When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.
- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not surrender dogs owned, in the care of or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt (04/20)

#### BREEDING

- 2.16 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.17 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. 08/14





- 2.18 A member shall not breed a bitch causing it to whelp **more than twice in any eighteen month period** without the prior approval of the member's Member Body. (07/16)
- 2.19 Number of Litters
- 2.19.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
- 2.19.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
- 2.19.3 Extenuating circumstances
- 2.19.3.1 A member may apply to Dogs West for permission for a sixth (6<sup>th</sup>) litter.  
The application is to include:
- a veterinary certification of fitness for further breeding issued in the last 30 days
  - the positive identification of the bitch – microchip
  - reasons for the need for a sixth litter
- 2.19.3.2 The member must have obtained written permission for the sixth (6<sup>th</sup>) litter PRIOR to mating the bitch
- 2.19.3.3 The permission is valid for a period of six months – after this permission must be re-applied for.
- 2.19.3.4 Under no circumstances will the registration of a seventh (7) litter be permitted. (04/17)
- 2.20 Maximum Breeding Age
- 2.20.1 A member shall not mate a bitch over the age of seven (7) years.  
Note: after the bitch's seventh birthday. (07/18)
- 2.20.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
- 2.20.3 Extenuating Circumstances
- 2.20.3.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
- a veterinary certification of fitness for further breeding issued in the last 30 days
  - the positive identification of the bitch – microchip
  - reasons for the need for a litter from a bitch of this age
- 2.20.3.2 The member must have obtained written permission PRIOR to mating the bitch
- 2.20.3.3 The permission is valid for a period of six months – after this permission must be re-applied for.
- 2.20.3.4 Under no circumstances will permission for a further litter be granted. (04/17)
- 2.21 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given prior to the mating on the basis of health or genetic reasons to the benefit of the breed. Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.  
The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6 – 8.4 (Added 10/10, Amended EAP 12/14)
- 2.22 A member shall not permit any of that member's pure bred dogs to be mated to a dog of a different breed, to a cross bred dog, to a non ANKC registered dog of the same breed, or to a dog not on the ANKC Main Register without the prior approval of the Association.
- 2.23 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.  
Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. 08/11, 04/13
- 2.24 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.
- 2.25 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.  
Puppies are to be microchipped and vaccinated prior to leaving the Member's care.
- 2.26 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.27 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.28 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 2.29 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.30 A member **must** register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.31 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
- 2.31.1 The breed characteristics;
- 2.31.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
- 2.31.3 Microchip number verification – transfer is the responsibility of the vendor in accordance with R19.
- 2.31.4 Responsible dog ownership information; and
- 2.31.5 All documentation required by the member's Member Body, including
- 2.31.5.1 a written receipt clearly stating whether the dog was sold with or without a Certificate of Registration (Main or Limited) - "with or without papers" shall mean the Certificate of Registration
- 2.31.5.2 any other conditions of sale and/or agreements (04/17)
- 2.32 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.33 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.34 A member shall not:
- 2.34.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. [07/15]
- 2.34.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

## GENERAL

- 2.35 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:
- 2.35.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
- 2.35.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.36 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.
- 2.37 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:  
"Please contact Dogs West on email: [k9@dogswest.com](mailto:k9@dogswest.com) to verify my membership."
- 2.38 A member shall not use or cause to be displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. (06/20)
- 2.39 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. (06/20)
