

#### **Amended Dogs West Regulations**

- Regulation A42 be amended to read:
  - A42 COMPLAINTS LODGEMENT OF
    - 42.1 Complaints from members of any ANKC Member Body, at either the date of lodgement, or the date of the incident must be accompanied by a lodgement fee of:
      - 42.1.1 Complaints lodged ten (10) working days of the date of the incident must be accompanied by a lodgement fee of \$150.00.
      - 42.1.2 Complaints lodged after ten (10) working days of the date of the incident must be accompanied by a lodgement fee of \$250.00.
    - 42.2 No complaint in relation to an incident at an event/ training will be accepted later than twenty (20) working days of the date of the incident.
    - 42.3 Complaints which do not relate to an incident at an event/training, such as a breach of the Code of Ethics or other general regulations, may be lodged within six months of the alleged breach. (10/18)
    - 42.4 Where a complaint be upheld, the lodgement fee will be returned to the complainant. The lodgement fee will be included in addition to any penalty handed down by the Protests & Disputes Tribunal/Appeals Board/Judges Board.

Effective immediately.

- Regulation T3.5.1 be amended to read:
  - 3.5.1 The pass mark for the final written theory exam will be 80% and will be decided from the average marks awarded by three members of the Board of Examiners. The Board of Examiners may appoint other suitable people to take the place of members of the Board, but no less than two members of the Board must mark the papers.

# PRESS RELEASE - AFGHAN HOUND SURVEY RESULTS

A survey was conducted by Dogs Australia last year to ascertain the feedback from all owners of registered Afghan Hounds in relation to the Minimum Breeding Age for Afghan Hound bitches being 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

The response received indicated support.

As this was an amendment to current regulations, the result of the survey was referred to the Dogs Australia Board of Directors for consideration at their February 2022 Special Board meeting where it was endorsed.

As a consequence, the following new clause will be added to Regulations Part 6 -The Register & Registration which will be effective from 1 July 2022:

# 8.16 Afghan Hound (Added 02/22- 6.1. Effective 01/07/2022)

The Minimum Breeding Age for Afghan bitches is 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months).

Breeders of litters whelped on or after 1st
June 2022 will be required to comply with the
requirements as a prerequisite to registration of any
litter on the ANKC Ltd Main Register. Litters which
do not meet the above requirements will only be
able to be placed on the Limited Register and will
be flagged not to be upgraded.

# **REQUIREMENT TO TRANSFER A DOG**

In January 2021 the Board of the ANKC resolved that -

'Effective 1 March 2021, it is the breeder/seller's responsibility, when disposing of a puppy/dog, to transfer the ownership of the puppy/dog to the new owner.'

Dogs West was one of the few State Member Bodies that did not already have such a Regulation in place.

We understand this is an added responsibility for Dogs West members. Please see below a list of frequently asked questions, and their answers, for your assistance.

#### · What's changed?

From 1 October 2021, Dogs West members must do one of the following within 90 days of disposing of a dog:

 Transfer the dog to the new owner/s by completing and submitting the relevant paperwork to Dogs West to transfer of the registered ownership of the dog

OR

- If there is an agreement between the parties that the dog remains in the current owner's name/s, lodge a 'Non-Transfer Agreement' with Dogs West that is signed by all parties
- If I am keeping a dog myself, do I need to do anything?
   NO.

Any dog remaining with you requires nothing further than registration.

 If a puppy buyer does not want the certified pedigree, do I still have to transfer the ownership?

YES.

The ANKC Regulations require the breeder/seller of a dog to transfer ownership.

 I don't have the Certified Pedigrees prior to the dog leaving. How do I get a dog buyer to sign the transfer?

You can have buyer sign the 'Application to Transfer/Lease a Dog' found at www.dogswest.com under Members - Application Forms and Agreements, when they pick up their dog

You can then attach this to the Certified Pedigree (signed by you) to lodge the transfer.

 Why is it the responsibility of the current owner to transfer the ownership?

The ANKC Regulations require the breeder/seller of a dog to transfer ownership.

 If I sold/disposed of a dog BEFORE 1st October 2021, am I responsible for the transfer of ownership?

Only dogs disposed of AFTER 1st October 2021 are subject to the new regulations.

 If I am placing a dog in a new home but wish to retain the registered ownership in my name (e.g. Breeders terms), what am I required to do?

Complete and lodge the 'Non-Transfer Agreement', with the applicable fee of \$45.

This will allow us to register the agreement of the new owner to NOT have the registered ownership transferred into their name.

 If I submit a litter registration after 1st October, do I need to pay the Litter Record fee?

NO.

The Litter Record Fee will no longer apply from 1st October 2021. Registration fees will now be charged per puppy only.

 I have a contract with my dog owner to say I will transfer the dog after it has been sterilised. What am I required to do?

Within 90 days of disposing of the dog, you still need to lodge either a 'Transfer of Ownership' or a 'Non-Transfer Agreement'. You can also utilise the 'Non-Breeding Agreement'.

 Will dog ownership records be made available to government agencies?

NO.

Dogs West will NOT share dog ownership records with a third party unless legally required to do so.

· Why were members not consulted about the change?

The amendment is not optional for Dogs West as it is required by ANKC Regulations.

The ANKC requirement came into effect in March 2021. Governing Council have considered all the options available since then and have tried to manage the impact on our members as much as possible.

Is Dogs West profiting from the change?

NO.

Every effort has been made to make this a cost-neutral process. Extensive financial modelling was done prior to the procedures, regulations and fees being finalised. Governing Council are ultimately responsible for ensuring the long-term viability of the Association and all associated costs need to be covered effectively.

· Where can I find the relevant regulation?





# TOP DOG IN OBEDIENCE TRIALS COMPETITION RULES

- 1. Qualifying Period 1st July until the 30th June
- Handlers are to submit their six (6) best scores obtained at sanctioned trials held in WA (except National trials) from Utility and/or Utility Dog Excellent classes
- 3. These scores must be gained under at least three (3) different judges
- 4. The submitted scores must include at least one (1) first place
- 5. Scoring: UD scores as awarded, UDX scores as awarded plus 2 points

In the event of a tie of 2 or more dogs, two (2) more scores are to be submitted and a count back will be implemented, based on the number of wins and placings gained with the eight (8) presented scores

- a) the dog with the highest number of wins
- b) the dog with the highest number of 2<sup>nd</sup> places
- c) the dog with the highest number of 3rd places

Less than 6 UD and/or UDX scores meeting the criteria:

Should there not be a dog with sufficient qualifying scores, then no award would be made for that year.

Scores must be submitted to the Canine Association by COB first Friday in July.

# TOP DOG IN RETRIEVING TRIALS

Points to be awarded in All Age and Championship Stakes held in Western Australia. To be eligible a dog must have been placed first in a least one of those trials in the year of competition.

Points must include placings from at least three (3) different judges.

Points	Championship	All Age
1 <sup>st</sup>	12	9
2 <sup>nd</sup>	9	6
$3^{rd}$	6	3
<b>4</b> <sup>th</sup>	3	

If two (or more) dogs score equal aggregate points for the year, the trophy shall be awarded to the dog gaining the most first places. If the dogs are still equal, second places will be counted and if they are still not separated third places will be counted. If the dogs still remain equal, they will then be declared joint winners and a trophy will be awarded to each of them.

The Retrieving Working Party, as part of the Events Committee, will be responsible for keeping progressive scores for publication in the Canine News.

# TOP 'DANCES WITH DOGS' DOG OF THE YEAR

- 1. Qualifying period 1st July 30th June
- Handlers are to submit their best six (6) scores obtained at sanctioned competitions in WA (exception National Trials) from Advanced or Freestyle classes, or a combination of both
- 3. Scores must be obtained under three different panels of judges.
- 4. Submitted Scores must include at least one first place.

In the event of a tie of 2 or more dogs, a count back will be implemented based on the number of wins and placings gained with the six presented scores.

- (a) the dog with the highest number of wins
- (b) the dog with the highest number of 2<sup>nd</sup> places
- (c) the dog with the highest number of third places

#### Less than six scores in meeting the criteria:

Should there be no dog with sufficient qualifying scores then no award will be made that year.

Scores must be submitted to the Canine Association by COB first Friday in July.

#### TOP AGILITY DOG OF THE YEAR

Qualifying period 1st July - 30th June

The scoring to be for the best six (6) **Masters** qualifying cards submitted for each dog.

That there must be a minimum of six (6) dogs physically competing (actual competitors following scratchings) in the Masters class before a place of qualifying card gained from that trial would become eligible. (11/04)

No Eastern States' cards to be accepted in the application for Top Agility Dog with the exception of qualifying cards gained at the National Agility Trial either in the qualifying rounds or the finals. **07/07** 

8 points being awarded for a first (1st) place

6 points being awarded for a second ( $2^{\text{nd}}$ ) place

4 points being awarded for a third (3<sup>rd</sup>) place

2 points for a non-placed qualifying card

In the event of a tie occurring, competitors will be required to submit their next three (3) best score cards. Scorecards will be considered in order with first places considered first, if a tie still exists then second place score cards will then be considered followed by third place cards and qualifying cards.

Scores with a copy of qualifying cards must be submitted to the Canine Association by COB first Friday in July by the Owner/Handler.

#### TOP JUMPING DOG OF THE YEAR

Qualifying period 1st July - 30th June

The scoring to be for the best six (6) **Masters** qualifying cards submitted for each dog.

That there must be a minimum of six (6) dogs physically competing (actual competitors following scratchings) in the Masters class before a place of qualifying card gained from that trial would become eligible. (11/04)

No Eastern States' cards to be accepted in the application for Top Agility Dog with the exception of qualifying cards gained at the National Agility Trial either in the qualifying rounds or the finals. (07/07)

8 points being awarded for a first (1st) place

6 points being awarded for a second (2<sup>nd</sup>) place

4 points being awarded for a third (3<sup>rd</sup>) place

2 points for a non-placed qualifying card

In the event of a tie occurring, competitors will be required to submit their next three (3) best score cards. Scorecards will be considered in order with first places considered first, if a tie still exists then second place score cards will then be considered followed by third place cards and qualifying cards.

Scores with a copy of qualifying cards must be submitted to the Canine Association by COB first Friday in July by the Owner/Handler.

# **SCENT WORK IN WA**

Western Australia competitors officially welcomed their first Scent Work trial in September 2021. With 24 entries at the first trial and ending up with a total of 19 passes on the day! A nice result after the training efforts for the previous, in some cases years of hard work.

The remainder of 2021, saw a further 5 trials between Sept to Nov totalling 10 elements and 12 classes including our first Advanced Classes on offer at our last trial of the year in November.

Our judges are capped at 80 entries a day and our last trial with two elements, both Novice and Advanced Classes on offer – resulted in EXACTLY 80 entries being received and not causing us to go to ballot.

Scent Work has turned into a fantastic supportive community that is proud to showcase the full spectrum of breeds including many non-traditional scent breeds; Chihuahua, Shih Tzu, Malamutes to Poodles, the list is long!

The future of Scent Work is bright in WA with new trainee judges currently proceeding through the training program, and more clubs expressing interest in adding trials to their annual calendar. To date we have had over 30 Scent Work Novice titles registered in WA and April will have seen the first classes on offer for dogs qualified for Excellent Class and interstate judges contracted for trials — a lovely progression for our sport!

# Vale - Patricia McKenna

Pat was a lady of many parts. She achieved success in many areas during her lifetime, but her most abiding interests were her dogs and her horses.

Pat grew up in Cottesloe on a property that fronted the railway line and, apart from the house held a bakery and small stables. Pat's father was a baker and right up to the late fifties he baked bread which he delivers to nearby suburbs by horse and cart. Knowing Pat I am sure that she would have been assisting in this business as a youngster

Pat had a passion for Cocker Spaniels and spent hours training them in the retrieving field as well as campaigning them in the show ring briefly. She had success in the field achieving a retrieving Champions title with at least one of her dogs. This is a feat that was unique in this state and possibly in Australia. Pat always approached her dogs in a positive way believing them capable of great skill in the field and always encouraging them to tackle the tasks with great patience. She had a few litters and her last dog that she worked in the field was a Dog called Radyr Silver Gem, a very stubborn dog who she worked hard with to achieve some success.

As well as working her dogs Pat involved herself in the judging aspect of dogs. She was a Championship All Breeds Judge as well as a Retrieving, Obedience and Tracking Trial Judge. She officiated in many parts of Australia.

As well as these facets Pat was generous with her time in taking many positions on the committee of the Gun Dog Club which included being Treasurer. Pat also was a very busy trainer for the club giving many people and their dogs a very good introduction to field and obedience work. She was always willing to help with events and her happy approach to life made her a very welcome person with which to work. She was a Life Member of the club.

Pat's other great passion was her horses. She was one of the first female licensed reinsman at the Trotting Track and travelled many kilometres to attend trotting meetings. After having to move from Cottesloe she bought a property in Banjup so that she could look after her horses on site and assist in their training. Once again her determination and dedication resulted in success.

Pat also had a very good singing voice and was an active member of the Gilbert and Sullivan Society in Perth for many years taking part mainly in the chorus of many productions. She was an active member of the choir at the Star of the Sea Church in Cottesloe for many years. This is yet another example of her willingness to serve.

To add another aspect to her varied life Pat was a State Champion and Representative at National Championships in Badminton.

Pat was employed by a firm in Fremantle as a bookkeeper for many years and I am sure would have been a valuable worker for the firm.

All in all Pat was a contributor who enjoyed life and was always willing to help other people. She was a tailblazer in many areas and is sadly missed.

- A Member shall not forge, falsify or misrepresent the signature of another Member or person on any document relating to the activities of Dogs West or the Australian National Kennel Council Ltd. (05/21)

#### HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- A member shall not engage in any behaviour that is contrary to the standards accepted by the community.
  - Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.

  - Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
  - Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. (07/15)
- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times.

This includes but is not limited to:

- Littering
- Damage
- Unacceptable behaviour
- A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. 08/11

- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. 08/11
- Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare
- Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
  - A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code.
    - 2.10.1 During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or
  - 2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. 04/17
- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to
  - When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.
- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not surrender dogs owned, in the care of or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt (04/20)

#### **BREEDING**

- 2.16 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.17 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. 08/14
- 2.18 A member shall not breed a bitch causing it to whelp
  - more than twice in any eighteen month period without the prior approval of the member's Member Body. (07/16)

# MEMBERS' CODE OF ETHICS (latest amendment May 2021)

# **Code of Ethics**



- 2.19 Number of Litters
  - 2.19.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
  - 2.19.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
  - 2.19.3 Extenuating circumstances
  - 2.19.3.1 A member may apply to Dogs West for permission for a sixth (6<sup>th</sup>) litter.
    - The application is to include:
    - a veterinary certification of fitness for further breeding issued in the last 30 days
    - the positive identification of the bitch microchip
    - reasons for the need for a sixth litter
  - 2.19.3.2 The member must have obtained written permission for the sixth (6th) litter PRIOR to mating the bitch
  - 2.19.3.3 The permission is valid for a period of six months after this permission must be re-applied for.
  - 2.19.3.4 Under no circumstances will the registration of a seventh (7) litter be permitted. (04/17)
- 2.20 Maximum Breeding Age
  - 2.20.1 A member shall not mate a bitch over the age of seven (7) years.

    Note: after the bitch's seventh birthday. (07/18)
  - 2.20.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
  - 2.20.3 Extenuating Circumstances
  - 2.20.3.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
    - a veterinary certification of fitness for further breeding issued in the last 30 days
    - · the positive identification of the bitch microchip
    - · reasons for the need for a litter from a bitch of this age
  - 2.20.3.2 The member must have obtained written permission PRIOR to mating the bitch
  - 2.20.3.3 The permission is valid for a period of six months after this permission must be re-applied for.
  - 2.20.3.4 Under no circumstances will permission for a further litter be granted. (04/17)
- 2.21 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given prior to the mating on the basis of health or genetic reasons to the benefit of the breed. Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.
  - The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6-8.4 (Added 10/10, Amended EAP 12/14)
- 2.22 A member shall not permit any of that members' ANKC Pure Bred Registered dogs, without prior approval from the Association, to be used in any mating which would result in a litter being ineligible for registration on the ANKC Register. This includes
  - 2.22.1 To a dog of a different breed
  - 2.22.2 To a cross bred dog
  - 2.22.3 to a non ANKC registered dog of the same breed or
  - 2.22.4 to a dog not on the ANKC Main Register
  - 2.22.5 a mating not in compliance with R2.1. 04/21
- 2.23 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.
  - Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. 08/11,04/13
- 2.24 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary
- 2.25 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.
  - Puppies are to be microchipped and vaccinated prior to leaving the Member's care.

- 2.26 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.27 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.28 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 2.29 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.30 A member must register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.31 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
  - 2.31.1 The breed characteristics;
  - 2.31.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
  - 2.31.3 Microchip number verification transfer is the responsibility of the vendor in accordance with R19.
  - 2.31.4 Responsible dog ownership information; and
  - 2.31.5 All documentation required by the member's Member Body, including
  - 2.31.5.1 a written receipt clearly stating whether the dog was sold with or without a Certificate of Registration (Main or Limited) "with or without papers" shall mean the Certificate of Registration
  - 2.31.5.2 any other conditions of sale and/or agreements (04/17)
- 2.32 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.33 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.34 A member shall not:
  - 2.34.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. [07/15]
  - 2.34.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

#### GENERAL

- 2.35 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:
  - 2.35.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
  - 2.35.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.36 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.
- 2.37 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:
  - "Please contact Dogs West on email:  $\underline{k9@dogswest.com}$  to verify my membership."
- 2.38 A member shall not use or cause to displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. (06/20)
- 2.39 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. (06/20)
