President Report



We have come to the official end of what has been a very long and a very hot summer. The days are drawing in, but the heat is continuing and I think we all look forward to more temperate days and nights.

They will however be different days ahead with our State Borders opening and the emergence of Covid within our

community. Whilst we have been fortunate in many ways during the pandemic, the end of isolation will be a relief for many cut off from family, friends and events.

With the border opening have come Covid restrictions. Dogs West will keep Members updated on what restrictions may apply at Dogs West from time to time, and how these may impact on events as they change. There has been initial contact from the Department of Local Government, Sport and Cultural Industries in relation to the drafting of the Regulations that will apply under the Stop Puppy Farming Bill amendment to the Dog Act, and of Dogs West inclusion in the process following the commitment from the Minister for Local Government, the Hon John Carey, when we met with him. We remain committed to working to get the best outcome for our Members and their dogs under this new legislation. I will keep Members informed of any developments. At this time, your fellow enthusiasts in New South Wales are responding to suggested changes to legislation in their State.

The recent action by the Norwegian Kennel Club to ban the breeding of Cavalier King Charles Spaniels and British Bulldogs, has raised concerns around the world, and re-ignited debate around the breeding of unhealthy dogs, brachycephalic breeds in particular.

Dogs Australia will be providing ongoing informed commentary on this to support our responsible breeders, and on other matters, and I encourage all Members to join the Dogs Australia Bush Telegraph Facebook Group so that you can be updated on new information to hand and learn how to share the knowledge and information about our wonderful dogs.

Real influence is gained by sharing knowledge and educating by example.

ANKC LTD IS SEEKING FEEDBACK FROM OWNERS OF ROTTWEILERS REGARDING THE FOLLOWING PROPOSAL.



The current regulation under Regulations Part 6 The Register & Registrations is as follows:

8.9 Rottweiler

8.9.1 For litters of Rottweilers born where the parents have been born after 1.1.97, these parents must show results of X-rays for hips and elbows. (Amended 10/13 – 5.6.4)

Proposal to add as 8.9.2:

8.9.2 Effective immediately, any Rottweiler born a Natural Bobtail will be eligible to be registered on the Limit Register only and flagged 'NOT TO BE UPGRADED'.

Rationale:

The adopted standard (FCI Standard No: 147) for the Rottweiler within Australia has now been updated as of 24 July 2018. A significant change to this updated standard is that it now reflects the length of the tail: "while positioned along the leg, the tail reaches approximately to the hocks or is a bit longer", and the Natural Bobtail is listed as a disqualifying fault.

RETRIEVING & FIELD TRIAL "HALL OF FAME" 2022 Nominations

In the first nineteen years of elections, the Australian National Kennel Council Ltd has received nominations for 56 dogs and 41 people to be considered for induction into the Retrieving & Field Trial Hall of Fame. From the nominations received 34 outstanding dogs and 24 exceptional people have been inducted.

The criteria for the two categories for selection are the following:

- Outstanding Gundogs (must be permanently retired from further competition and have not competed for the past 12 months, or be deceased)
 - (a) Their record as a winning dog i.e., CLUB STAKE DATE JUDGE PLACE and/or
 - (b) Their production record.
 - (c) The eligibility for a dog should be based on its entire competitive career and previous record as a producer, not merely for a particular win or for a heroic deed within the field and retrieving trial sphere.
 - (d) Subject to the receipt of a formal application, dogs that have been awarded the title of Grand Champion and have gained a total number of points equal to, or greater than, twice the total number required for that award, shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.
 - (e) Subject to the receipt of a formal application, dogs winning at least two National Championships in the same discipline shall automatically be inducted into the Hall of Fame. Such applications must include full particulars and a brief resume of the dog's career.

Prominent Persons:

Their record of a broad combination of accomplishments as:

(a) Club official (b) Judge (c) Owner (d) Handler

The distinction of nomination should be accorded to those who have made outstanding contributions to the field or retrieving game. Nominees should be givers to the sport and not takers.

Nominations are now being called for the current year. In addition to applications submitted in relation to Outstanding Gundogs 1 (d) and 1(e), a maximum of two other outstanding gundogs and two prominent persons may be elected each year.

Nomination:

Clubs or Members may nominate DOGS and PEOPLE considered worthy
of awards, including full details of accomplishments within the above
categories and with verification. In the case of dogs, nominations should
include the full name, title, owner and date of birth.

[Please note it is a condition of nomination that the nominator/s provides accurate written material supporting the nomination. In the absence of such accurate supporting material, or should the supporting material later prove to be inaccurate in areas of significance, the Selection Panel for the ANKC Ltd Retrieving & Field Trial Hall of Fame reserves the right to reconsider its decision and if appropriate, delete the name of the Prominent Person or Outstanding Dog from the list of inductees.]

- Nominations shall close on the 31 May 2022 at respective Member Body offices for forwarding to ANKC Ltd.



Fromthe Compliance Officers Desk

From the onset, the main focus of the role of 'Dogs West Compliance Officer' has been about 'prevention and education'. Dogs West aim is for all members to understand and comply with the regulations, and to do what we can to assist with this. This issue we will focus on -

Advice for Stud Dog Owners

It can be a great compliment when someone asks to use your stud dog in their breeding program. Owning a Stud dog comes with many responsibilities which you should be aware of, some of which are listed below.

It is up to you to make sure you are meeting all of your obligations.

It is worth saying that Dogs West strongly recommend that you work out the terms and conditions of your stud arrangements, and have clear written agreements in place, well before the mating takes place. Stud agreements are a private civil matter between the Stud dog and Bitch owners and, unless there has been a breach of the Regulations, Dogs West will not intervene.

It is up to you to ensure your interests are protected.

There are a number of ANKC and Dogs West Regulations that our members must be compliant with and Dogs West members who own Stud dogs should be aware of the Regulations before allowing their dog to be available for stud.

This regulation applies to stud dog owners and bitch owners alike.

See Regulations Section R - The Register and Registration

As the stud owner you must meet the requirements of following Section R regulations -

- R2.1.4 The registered owner of the stud dog for the litter must be a financial member of an ANKC Ltd member body at the time of the mating.
- R2.1.5 The service declaration on the litter registration form must be signed by the registered owner of the stud dog and provided to the registered owner of the dam.

If you stand your dog at stud you need to take all reasonable steps to ensure that a resulting litter would comply with the requirements for registration.

- R2.1 Dogs whelped shall be eligible for registration by Dogs West provided that:
- 2.1.1 At least one of the registered owners of the dam is resident in Western Australia and is a member of the Association, irrespective of where in Australia the litter is born, except as in 2.1.2.
- 2.1.2 where a prefix is jointly owned, registered and maintained in more than one State or Territory, the litter must be registered in the State or Territory in which the pups are born.
- 2.1.3 the owner of the dam of the litter must:
 - be a financial member of an ANKC Ltd Member Body and
 - have a current financial ANKC Prefix at the dates
 - o of mating and
 - o of whelping and
 - o of registration.
- 2.1.4 the registered owner of the stud dog for the litter must be a financial member of an ANKC Ltd member body at the time of the mating
- 2.1.5 The service declaration on the litter registration form must be signed by the registered owner of the stud dog and provided to the registered owner of the dam.

Other things to consider and to discuss with the breeder before allowing your dog to be used at stud are -

- 1. Have the ANKC Health requirements for your breed been met?
 - These can be found in the ANKC Ltd Regulations Part 6 The Register and Registration and are dependent on breed.
- 2. Is this a first-generation mating?
 - First generation matings (father/daughter, mother/son, brother/sister) are not permitted.
- 3. Is the bitch the correct age?
 - In general, a bitch must be over 12 months and under 7 years to be bred from. There are, however, additional requirements for some breeds. These can be found in the ANKC Ltd Regulations Part 6 The Register and Registration
- 4. Has the bitch had litters previously?
 - If so, how many and when? A bitch must not whelp 3 times in any 18 month period, and must not whelp more than 5 times overall, without prior permission from the member body.

This list is not exhaustive and is intended as a guide to assist you in meeting the requirements. We are happy to help if you have further questions. Our processing staff can clarify details for you and check individual details prior to mating taking place.

RETRIEVING TRIALS IN W.A. - AUGUST 2021

On August 7th the Golden Retriever Club held their All Age trial Gidgegannup, with Judge being Allan B. Ten dogs entered, and we all knew that being so close to our State Champs, that Al would up the ante. Triple retrieves on all runs required so much obedience, without losing impulsion. Four dogs completed the trial successfully, and Mark Jackson and his cocker spaniel, Ozzie of Aberdeen, won first place on 153 points, and gain his R.T. Champion title. Congratulations!! Second place on 139 points was RT Ch Ellishea Wyatts Flash, a Goldie owned by Heather Ellis, and third place went to Boomermagic Solar Flare and Maggie Hankinson on 136 points.

August 8th and the Labrador Club had their final Novice and Restricted, with judge for the day Catherine T. Nine dogs entered in Novice, and the challenges of this site whittled down the numbers until four dogs completed the three runs. In first place on 157 points was Sharp Shooters Go For Broke (Imp USA), a handsome GSP owned by Ryan Burke. Second place was Ch Korskote Treasure Trove, a GWP owned by Tony Merceica, with 151 points. In third place on 150 points was Burkes JT a GSP dog owned by Ryan Burke. Restricted stake had ten dogs entered, with a tricky little two bird up first, followed by a doublerise retrieve, and lastly, a mark and blind. A great spectator run, being partly run in water. First place was Brigodee Roll The Dice owned by Kerry Webster, with 170 points. Second place was Ellishea Wyatts Le Roux and Alex Deasy on 160 points, and third place, Korskote Treasure Trove and Tony Merceica with 145 points.



The 14th and 15th of August were Linc Sullivan Memorial (The Cup), and the Flash Memorial shield, All Age trials. The contracted judge was unable to attend because of covid restrictions, so Allan B. stepped up to judge the Cup and Maggie H. accepted the appointment for the Flash. Many thanks to both. The Cup on the 14th was held at Jennacubbine in pretty much perfect weather, with nine dogs entered for the four run stake. All runs were triple retrieves, there were lengthy marks, long blinds requiring accuracy, a double fall, doublerise and two bird retrieves. Several dogs lost their way, and by run four, only two dogs remained, both of which completed the final run. Presentations had in first place RT Ch Brigodee Diamonds Bow Ty N Tux and Kerry Webster on 220 points, and, on top of that a CM (Certificate of Merit) was awarded to Tux for his outstanding work. In second place on 200 points was GRD RT Ch Ellishea Just Cussy CM and Heather Ellis. The other awards for this trial were; Best Veteran Ellishea Just Cussy and Heather Ellis. Best Non RT Ch: Boomermagic Booms Addiction and Ann Graham. Best team of three: Ellishea Just Cussy: Bodhran Miss Daisy and Ian Molyneux: Boomermagic Booms Ricochet and Colin Hankinson.

August 15th and the Flash All Age was underway with eight dogs starting the four run trial. Maggie had put a lot of time in her selections. With relocations, plenty of water hazards and undulations, the runs were a challenge. The best team of three was Ellishea Just Ned; Ellishea Just Cussy; Wauchope Summer Storm.



HM2 CODE OF CONDUCT

- A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- A member shall not engage in any behaviour that is contrary to the standards accepted by the community.
 - Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.

Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. 08/11
- Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
 - A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code.
 - 2.10.1 During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.
 - 2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. 04/17
- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to
 - When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.
- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not surrender dogs owned, in the care of or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt (04/20)

BREEDING

- 2.16 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.17 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. 08/14
- 2.18 A member shall not breed a bitch causing it to whelp
 - more than twice in any eighteen month period without the prior approval of the member's Member Body. (07/16)

MEMBERS' CODE OF ETHICS (latest amendment May 2021) Code of Ethics

- 2.19 Number of Litters
 - 2.19.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
 - 2.19.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
 - 2.19.3 Extenuating circumstances
 - 2.19.3.1 A member may apply to Dogs West for permission for a sixth (6^{th}) litter.

The application is to include:

- a veterinary certification of fitness for further breeding issued in the last $30~\mathrm{days}$
- the positive identification of the bitch microchip
- reasons for the need for a sixth litter
- 2.19.3.2 The member must have obtained written permission for the sixth (6th) litter PRIOR to mating the bitch
- 2.19.3.3 The permission is valid for a period of six months after this permission must be re-applied for.
- 2.19.3.4 Under no circumstances will the registration of a seventh (7) litter be permitted. (04/17)
- 2.20 Maximum Breeding Age
 - 2.20.1 A member shall not mate a bitch over the age of seven (7) years. Note: after the bitch's seventh birthday. (07/18)
 - 2.20.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
 - 2.20.3 Extenuating Circumstances
 - 2.20.3.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
 - a veterinary certification of fitness for further breeding issued in the last 30 days
 - the positive identification of the bitch microchip
 - · reasons for the need for a litter from a bitch of this age
 - 2.20.3.2 The member must have obtained written permission PRIOR to mating the bitch
 - 2.20.3.3 The permission is valid for a period of six months after this permission must be re-applied for.
 - 2.20.3.4 Under no circumstances will permission for a further litter be granted. (04/17)
- 2.21 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given <u>prior to the mating</u> on the basis of health or genetic reasons to the benefit of the breed. Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.

The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6-8.4 (Added 10/10, Amended EAP 12/14)

- 2.22 A member shall not permit any of that members' ANKC Pure Bred Registered dogs, without prior approval from the Association, to be used in any mating which would result in a litter being ineligible for registration on the ANKC Register. This includes
 - 2.22.1 To a dog of a different breed
 - 2.22.2 To a cross bred dog
 - 2.22.3 to a non ANKC registered dog of the same breed or
 - 2.22.4 to a dog not on the ANKC Main Register
 - 2.22.5 a mating not in compliance with R2.1.04/21
- 2.23 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.
 - Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. 08/11,04/13
- 2.24 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.
- 2.25 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.
 - Puppies are to be microchipped and vaccinated prior to leaving the Member's care.

- 2.26 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.27 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.28 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 2.29 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.30 A member must register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.31 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
 - 2.31.1 The breed characteristics;
 - 2.31.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
 - 2.31.3 Microchip number verification transfer is the responsibility of the vendor in accordance with R19.
 - 2.31.4 Responsible dog ownership information; and
 - 2.31.5 All documentation required by the member's Member Body, including
 - 2.31.5.1 a written receipt clearly stating whether the dog was sold with or without a Certificate of Registration (Main or Limited) "with or without papers" shall mean the Certificate of Registration
 - 2.31.5.2 any other conditions of sale and/or agreements (04/17)
- 2.32 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.33 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.34 A member shall not:
 - 2.34.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. [07/15]
 - 2.34.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

GENERAL

- 2.35 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:
 - 2.35.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
 - 2.35.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.36 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin
- 2.37 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:
 - "Please contact Dogs West on email: <u>k9@dogswest.com</u> to verify my membership."
- 2.38 A member shall not use or cause to displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. (06/20)
- 2.39 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. (06/20)
