As I write this report today, I am searching for more detailed information on the newly announced changes to COVID-19 restrictions and what they mean for activities and events for our Members.

It has certainly been a very different and, at times, difficult time under COVID-19 restrictions, and we continue to work to ensure that we meet the changing requirements for the safety and well-being of our Members and staff.

Negotiating the restrictions to understand how they apply to Dogs West has been challenging, and decisions made are always with a view to compliance to avoid having our grounds closed and fines being incurred.

I am sure we are all looking forward to once again enjoying the full range of activities we have with our dogs.

The pandemic has impacted on the financial management of our organisation, but we have been fortunate to qualify for the jobkeeper subsidy, meaning that we could both retain the services of our staff, and be financially supported during this time.

As COVID-19 Restrictions are lifted, we will work with Clubs to assist as much as possible to get events up and running again, and we will continue to keep all Members informed of any decisions made via our e-newsletter.

At this time we are awaiting a decision regarding the Perth Royal Show. As the primary opportunity for our dogs to be showcased to the public of Western Australia, we look forward to working with the RAS should a decision be made to go ahead with an event which includes our Members and dogs, should that be achievable.

The next couple of months will present a clearer picture of our financial situation against the budget that has been agreed by Governing Council for the coming year. Budgets are not absolutely set in stone and will be amended if required to ensure the financial well-being of the organisation.

As the election period opens for the roles of President and three Councillors, I urge all Members to consider who has nominated for these roles and to cast your vote. Elections are your opportunity to have a say.

Dogs make us happy, because if dogs do anything well, it's being happy themselves, and happiness—bless it—is catching.

CEOReport

I would like to extend my appreciation to all members for their consideration and patience during the close down of the office during the peak of the COVID-19 restrictions. With only one staff member, occasionally two, physically in the office to answer phone enquiries, the members' assistance in making more use of emails was very useful. The staff members working from home were able to access their emails to provide answers to the members' queries.

As the COVID restrictions are updated by the government, Dogs West will amend the requirements in accordance with this information. Every increase in allowable numbers will allow more events to recommence. Arrangements through the office for schedules and advertising will be flexible to assist affiliates get underway with events for their members.

The compliance with number restrictions on the grounds is difficult with the extra people that exhibitors may bring with them and any public attending. Club committees cannot be expected to try to count heads – especially when there is more than one show on hence the delay in commencing conformation shows. Members will need to realise that conformation shows booked for the grassed area may have to be conducted in the rain. If other shows are booked under the pavilion, it will not be possible for shows on the grass to just move under the pavilion as it will then exceed the allowable number.

During the close down of the grounds, Nathan has been busy completing the filling of the kerbed islands with either broken bricks or mulch.



The area behind the amenities building has been improved with a limestone wall and the retaining wall near the compound has been repaired by Ben from AClass Limestone.

The corella damage to the lighting and parking towers' cabling has been repaired and those cables not targeted yet have had a protective sleeve installed. A new parking tower has also been installed on the Ranford Road side of the large island between the two arenas.

There are plans in place to increase the planting of new trees in the areas around the lower arena. Hopefully these will be in soon to take advantage of the winter rains with a consultant attending the grounds to advise on varieties to plant and positioning.

D Important Notice to Members

All Membership Renewals will be due from 1 July and payable by 31 July 2020. If you do not renew your membership within 3 months of the due date, you will cease to be a member of the Association.

We remind all members of the following regulations:

A11. ARREARS OF SUBSCRIPTIONS AND OUTSTANDING ACCOUNTS

- 11.1 Any subscription not paid within thirty (30) days of the first day of the financial year shall be subject to a Late Fee, as prescribed in the list of charges.
- 11.2 Any person whose subscription shall be unpaid for three (3) months from the first day of the financial year shall be deemed a Lapsed Member of the Association and not be entitled to any privileges of membership.

If a Lapsed Member offers to pay the annual membership fee:

- 11.2.1 the Association may, at its discretion, accept that payment; and
- 11.2.2 if the payment is accepted, the person's membership is reinstated from the date the payment is accepted with no requirement to complete a Membership Application form.
- 11.2.3 The Lapsed Member is required to pay the current annual membership fee and the late fee (see A11.1).
- 11.3 Any person whose subscription shall be unpaid for twelve (12) months from the commencement of the financial year shall cease to be a Member of the Association.
 - 11.3.1 As a non-member of the Association, they will have to complete a Membership Application form and pay the establishment fee along with the current relevant membership fee.
- 11.4 Members who fail to pay outstanding accounts, other than subscriptions, within a period of three (3) months will have their privileges of membership withdrawn until the monies owed have been paid. **(07/19)**

Amended CAWA Regulations

Due to review and approval of ANKC Part 5 Conformation Shows effective 1 July 2020, the following amendments have been made to the Dogs West regulations.

All conformation exhibitors should make sure that they are aware of all the content of the ANKC regulations Section 5 – Shows.

B16 ELIGIBILITY OF EXHIBITOR, COMPETITOR AND EXHIBIT

- 16.5.1 Conformation Events Proprietary Interest
 - 16.5.1.1 No person shall enter or exhibit a dog in any sanctioned conformation exhibition at which a judge who is a member of the competitor's immediate family, or who resides at the same address, or who has had a proprietary interest in such dog whether solely or in partnership is scheduled to officiate
- 16.5.1.2 A person may not enter, exhibit or handle under a judge officiating at a conformation show where:
 - a. The person is a member of the judge's family and/or resides at the same address as the judge.
 - b. The judge has or has had any proprietary interest in a dog or dogs solely or in partnership with the member within a period of **12** months prior to the conformation show.
 - c. Where the judge has handled any dog owned, leased or part leased by the person within a period of **12** months prior to the conformation show.
 - d. The person has handled any dog owned or part owned or leased, or part leased by the judge in a period of **12** months prior to the conformation show.
 - e. The person has accommodated the judge or been accommodated by the judge within a period of **12** months prior to the conformation show or intends to accommodate the judge within **24** hours after the conformation show
 - f. The judge has trained or groomed for reward, for gift or favour a dog owned, or part owned, leased or part leased by the person in a period of **12** months prior to the conformation show
 - g. The dog was bred by the judge or the judge's family.
 - h. Either the exhibitor or the judge has used a stud dog belonging to the other within the last **6** months

B21 CATALOGUES

- 21.1 Catalogues are not to be made available prior to one hour before the advertised start time of a conformation show. Royal shows and cluster shows' catalogues may be released one hour prior to the first day or the first show.
- 21.2 In Agility and Obedience events a dog will be allocated a separate competitor number for each class in which it is entered.
- 21.3 An affiliate must retain a copy of the entry forms for a minimum of three (3) months.
- 21.4 An affiliate must retain a marked catalogue and records for the event for a minimum of twelve (12) months.

B37 JUDGES APPOINTMENTS - CONFORMATION

- 37.2 Championship
 - 37.2.1 A Judge must not duplicate assignments in the same breeds and/or groups within a minimum

of three (3) months of each other and within a minimum of 200 kilometres at Championship Shows irrespective of State boundaries.

Note: This will not apply to Neuter Only shows.

37.2.2 A judge cannot exhibit, and any dog owned by a judge cannot be exhibited, at a conformation show where that judge has been on the panel at one of the conformation shows using the same panel of judges at a cluster of shows.

Section C Sanctioned Shows

C2.5 OTHER CLASSES

2.5.3 Breeders' Team Minimum of four dogs six months of age and over of the same breed, bred under one prefix each of which has competed in at least one other breed class or neuter class at the same approved show.

C10 SCRATCHING OR WITHDRAWAL OF ENTRIES:

C10.4 A judge will excuse from the ring, any dog exhibited or handled by any person who has handled or assisted as a runner any dog owned or part owned, leased or part leased by that judge within a period of twelve (12) months.

C21 HANDLING and CONTROL of DOGS

Handling of dogs is to be done in a humane way that will not cause distress to the dog.

In particular, lifting an exhibit from the ground to the table by means of head and tail is **not** permitted.

Expressions Of Interest - Scent Work Foundation Judges Training

The Foundation Scent Work Judges' Training Scheme will be conducted at a national level in 2020 under the auspice of the ANKC National Scent Work Committee.

The Foundation Scent Work Judges' course will formally commence on 1st September 2020 and is expected to conclude in early 2021. The course will include theory and practical components, with theory and practical examinations at the completion of the course.

There is a course fee of \$71 which must be submitted with your application.

Applicants must also include documentation supporting their claims against the Eligibility Criteria for the program (see below). This should not be more than 1-2 page(s). Further information will be sought if required. Aspirants must be approved by their member body and assessed by the National Scent Work Committee as suitable to be admitted to the Foundation Judges' course.

Appointment of Scent Work Foundation Judges will be through the ANKC member bodies based on recommendations from the National Scent Work Committee.

The eligibility criteria for the Program include - an applicant must:

- Be a member of a Member Body or, if not a member, become and remain a member of the relevant Member Body;
- (b) Be over eighteen (18) years of age by the closing date for applications;
- (c) Reside in the State or Territory of application for admission to the Scheme:

- (d) demonstrate proven Scent Work knowledge as a result of either formal qualifications and/or relevant training courses with proven skills and/or experience in training a dog(s) in scent work in either a professional or dog sports capacity;
- (e) demonstrate skills and experience in instructing in Scent Work:
- (f) demonstrate a commitment to actively participate in Scent Work trials including as an organiser, a steward, a judge or other official.

Consideration may be given on an exception basis to expressions of interest for the Foundation program that meet most (but not all) of these criteria, where the individual can demonstrate the capacity to meet the requirements within a reasonable time.

Expressions of interest addressing the Eligibility Criteria and with a completed application form and application fee should be submitted to your Member Body by 14th August 2020.

Holistic Enrichment Ideas

With us spending more time at home, now is the perfect moment to introduce and explore new activities with our dogs. You'll be surprised by what fun you can have, as well as challenging your dog in a healthy way.

There has been a big buzz around enrichment, but what is it exactly and why is it so valuable to be doing for your dog? The definition of enrichment itself is "*the action of improving or enhancing the quality or value of something*". In loving our dogs, we want to do the best we can for them, so when applying enrichment to their lives, this can take many forms and is well worth thinking outside the square.

By bringing new approaches beyond a typical walk and food dispensing toys (which are all highly valuable!), we get to challenge the status quo for our dogs, which itself is enriching. This fires up neurons that will have the added benefit of taking idle energy away from less desirable behaviours and making it productive.

With a holistic approach, we are looking across a range of options that have interconnected benefits for our dogs physically, mentally, emotionally and spiritually. Keep in mind, every dog is an individual and will have their own abilities, strengths and preferences. These ideas are options to try, and depending on your own dog's breed, age and personality, you may find they gravitate to some things more than others. My advice is to do what is appropriate, fun and safe for your individual dog and circumstances. Try something, and don't be afraid to shelve it and go onto something new. Having a rotation of games and experiences to draw from, is an easy way to bring balance and spice things up.

A high energy dog will equally benefit from the more 'yin' activities that have them slowing down and concentrating. Likewise, an older or more mellow dog may benefit from physical activities that introduce gentle movement to increase range of motion and circulation. Be careful not to attempt to tire your dog out with constant, high intensity repetition games, such as fetch; this is very hard on the body and can also whirl your dog up mentally.

Below are ideas to consider, and they may need further research to introduce and apply appropriately with your dog. When in doubt, it is beneficial to seek support from professionals in the field with many offering remote services.

Physical Movement, Brain games and Conditioning:

- Set up an obstacle course using chairs, boxes, books etc, for your dog to go under, over and weave around.
- Create a circuit, with different skill sets to practice at each location, such as with Rally Obedience.
- Try trick training; get ahead of the game with practice at home, ready to jump into Trick Dog Trials as the new ANKC sport emerges. You can have a lot of fun with this and join various groups online for support.
- Scentwork is another ANKC recognised sport, so it is a great time to start teaching foundations while at home.
- Set up scavenger hunts, to get that nose working. It could be as simple as a scatter feed, or up the ante and have the kids do an Easter Egg style hunt by hiding treats in the home or garden and encourage your dog to "Go-Seek".
- Take advantage of all opportunities available to you by adding an extra dimension to their world (in a way that doesn't encourage unwanted behaviours) for example, if you have poles in the garden get them weaving, or if you have a stable, raised surface, get them to jump up onto this to find a toy or treat.
- Teach stair walking; most dogs will prefer to take the stairs at speed which takes less effort. So, by slowing them down to walk the stairs, you will engage different muscles and get them thinking about limb placement for controlled movement. Help them by using a food lure and supporting with your body as a guide. This can be a great one for increasing muscle tone in the rear end and is an easy activity with no set up. As a bonus it gets you both doing some extra physical activity.



Learning to walk up stairs in slow and controlled way

- Introduce body awareness and improve proprioception, with home style Cavaletti, using brooms and mops laid along the ground, then propped up. Have your dog walk over the course in the same direction and watch them process where to be lifting and placing their limbs and paws.
- Alternatively, bring in some rear end awareness, by having your dog learn to pivot on a block or old-style round biscuit/chocolate tin filled with stone or sand and tapped up. This is a multiple step process, where they learn to keep their 2 front feet on the box and swivel their back end around. This can help with general lead work and positioning for other games and sports.
- Use a variety of food dispensing toys to mix things up from licking, chewing to bopping with the nose. They also don't need to be anything fancy; for example, with more online orders, many people have extra cardboard boxes coming in. Place a treat inside, and cross over the box lids to have a closed

fold or add tape, and watch the fun begin. Of course, the value of Toilet paper has gone up, so get your values' worth by folding the edges of a used toilet roll with a treat inside for your dog to rip and tear apart.

- Incorporate mindgames by creating your own toys or using Puzzles with treats such as Nina Ottosson toys, which are a great game to play together.
- Set up a Snuffle mat for indoor quiet activity in a small space, there is a reason they have become very popular in recent times. Why not get the kids involved in making one as well, to get 2 enrichment activities for one idea. Licky mats also can be purchased or set up using a silicon bench protector or even smearing food over a large food lid.
- You can take it up a level by using a shell pool to create a snuffle pit. This
 is a great one for all seasons; where you can use leaf litter, or sand and hide
 some treats or toys amongst it for your dog to hone in their natural foraging
 skills. You can switch it up with or water or fill with empty plastic bottles
 instead.
- Teach your dog how to play Magic Cups, by getting them to signal a cup with a treat under it. You can then build this up to multiple cups, and slide them around to have your dog guess which cup the treat is under.
- Have a Toybox with a lid, rather than having all toys out with free access, encourages your dog to choose what they would like to play with. By rotating toys, you will keep the interest high and it is always a lot of fun to watch them poke around and choose.




Palpation and handling practice

Practical Enrichment:

- o Training for calm handling and husbandry, capitalises time into making general care much quicker and a less stressful experience. Teaching your dog how to accept and even enjoy ear cleaning, nail trimming and teeth brushing, is well worth the investment in time. All of these should be worked on at your dog's pace, making it an enjoyable experience by doing little steps to desensitise them with a high rate of treats.
- Physically palpating (by gently moving your hands over your dog), can help them feel better about handling when they are checked over by the vet or when they go to the groomers. It is also a great opportunity to help you become more in-tune with your dog's body. Notice areas that may feel extra tight or have hot zones, to indicate regions needing some extra TLC.
- Sound desensitization can help dogs with noise phobias, such as with storms, but is also fundamental in socialising puppies to a range of novel noises. Play different noises in the background at a low level to start, while doing an activity with your dog. You can gradually increase the volume while making the experience fun.
- Have the family do dress-ups with costumes, sporting equipment and random items you have at home. For example, the kids can do an Easter hat parade for a bit of fun. This is particularly important with current reduced options for socialising puppies, to better prepare them for different situations in future.
- If you do have a new puppy addition, be very mindful during this time of the importance of socialising during their critical period. It plays such a huge role in shaping who they become as adults and how they interact and respond to their world. Remember socialising is about becoming a welladjusted member of the family and society, not just about meeting other dogs. Less is important too, more so than ever, every dog should be getting practice being by themselves, so they can cope when things do go back to normal.

Diet enrichment:

- o We have touched on different ways to feed, but have you thought about adding enrichment in **what you feed**. I am a big believer in feeding biologically appropriate fresh food, with benefits for long-term health, vitality and nutrigenomics. Think about how you would feel getting the same brown pellets for every meal, versus the excitement of different tastes and textures.
- o Feeding the right food is important and dependent on how sensitive your dog is. A general baseline is to 'feed the rainbow', by trying new types of fruits and vegetables, along with different animal proteins in muscle meat, offal, eggs and fish. Switching out 20% to fresh food, is an easy way to increase health benefits and reduce inflammatory markers. Be sure to practice good hygiene standards, as you would with your own meal prepping, and watch your dog's face light up with something new.
- Raw meaty bones are great for encouraging chewing, ripping, and tearing, which use a dog's dental anatomy to the max and engage biological needs. Chewing itself releases endorphins, creating a feel good for your dog, while cleaning teeth and boosting their nutritional intake. The right bone is important (no cooked bones or highly dense weight bearing bones), supervision is a must, and choose the type appropriate for your dog's size and chewing style.

Emotional Enrichment for Team Bonding


Being involved in the above will boost your relationship with your dog and the following add an extra layer for your connection.

- In still having access for outdoor exercise, try a different walk where your dog decides which direction (within reason) and how long he or she spends getting to smell a spot. You may find your dog slightly confused, and looking to you for guidance, but be patient and allow them the time to figure it out. For those people that are used to getting from A to B very quickly, this is also a positive mental challenge, for you to pull back and see where your adventure takes you.
- Try play without toys, by mimicking play bows and encouraging chase me games, and others like hide and seek.
- Get hands on and massage your dog, by using slow or circular strokes down and along the body. This feedback system is also very soothing for us, increasing our serotonin levels. Set up an area on the ground (or comfortable for your dog on a raised surface), and notice what areas your dog is most receptive to and what pressure is preferred.
- In building on the power of touch you can learn how to incorporate stretches into your dog's routine. This will increase circulation and keep range of motion strong. Likewise, Tellington Touch or T-Touch is a great avenue to explore, in helping to ground your dog's nervous system.
- For sensory enhancement, you can try safely incorporating essential oils in this routine. Be sure to use therapeutic grade oils that are safe for dogs; and a little goes a long way, so it is important to use a carrier oil at the

right dilution. You can include your dog in the choice by allowing them to sniff the closed bottles at a distance and see what they gravitate to. Once diluted, you can rub in your hands and gently stroke and massage into their body (avoiding the face and eyes).

And now for something completely different... try some Yoga, Pilates or 0 floor exercises; this is great for your own physical movement, and mindset. Go in with a sense of humour and your dog will have some interesting entertainment to watch. Your breathing will create a calmer atmosphere, and if they choose to participate, you may not have a straightforward session, but you will have a good laugh in the process!

The beautiful thing about taking time to be present and enjoy watching your dog live in the moment, is you will have your own benefits that come from mindfulness. This will bring inner calm; and this centring will help stimulate your parasympathetic nervous system (the 'rest and digest' phase we want to be in), that boosts your own health and state of being. Research has shown how perceptive dogs are to our emotions, so working on our own stress levels, in turn helps our dogs. This is win-win and will help everyone move through these challenging times, while having some new skills to keep for life!

HM MEMBERS' CODE OF ETHICS (effective 1 March 2008) HM1 ACKNOWLEDGMENT

Each person, when signing an application for membership or renewal of membership of the Canine Association of Western Australia agrees to the following:

- · to be bound by the ANKC Ltd regulations and rules
- to be bound by the Constitution, Rules and Regulations of the Association
- · to be bound by the Association's Code of Ethics
- To allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. 04/17

HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- 2.2 A member shall not engage in any behaviour that is contrary to the standards accepted by the community.

Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.

- Bullying is defined as repeated inappropriate behaviour direct or indirect, whether verbal, gesture, physical or otherwise, conducted by one person or persons against another person or persons.
 - This includes, but is not limited to:

Cyber bullying – placing an offensive or hurtful public message, image or statement on a social network site or other public forum where that message, image or statement can be viewed and/or repeated by other people will be regarded as bullying behaviour.

- Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
- Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. (07/15)
- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times.

This includes but is not limited to:

- · Littering
- Damage
- · Unacceptable behaviour
- Bullying

- 2.4 A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 2.5 A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 2.6 A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. 08/11
- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. **08/11**
- 2.8 Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- 2.9 Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
- 2.10 A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code.

2.10.1 During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.

 $2.10.2\,$ Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. 04/17

- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.

When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.

- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not surrender dogs owned, in the care of or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt (04/20)

MEMBERS' CODE OF ETHICS (latest amendment April 2020)

BREEDING

- 2.16 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.17 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. **08/14**
- 2.18 A member shall not breed a bitch causing it to whelp
 - more than twice in any eighteen month period without the prior approval of the member's Member Body. (07/16)

2.19 Number of Litters

- 2.19.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
- 2.19.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
- 2.19.3 Extenuating circumstances
- 2.19.3.1 A member may apply to Dogs West for permission for a sixth (6th) litter. The application is to include:

- a veterinary certification of fitness for further breeding issued in the last 30 days

- the positive identification of the bitch microchip
- reasons for the need for a sixth litter
- 2.19.3.2 The member must have obtained written permission for the sixth (6th) litter PRIOR to mating the bitch
- 2.19.3.3 The permission is valid for a period of six months after this permission must be re-applied for.
- 2.19.3.4 Under no circumstances will the registration of a seventh (7) litter be permitted. (04/17)
- 2.20 Maximum Breeding Age
 - 2.20.1 A member shall not mate a bitch over the age of seven (7) years. Note: after the bitch's seventh birthday. (07/18)
 - 2.20.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
 - 2.20.3 Extenuating Circumstances
 - 2.20.3.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
 - a veterinary certification of fitness for further breeding issued in the last 30 days
 - the positive identification of the bitch microchip
 - reasons for the need for a litter from a bitch of this age
 - 2.20.3.2 The member must have obtained written permission PRIOR to mating the bitch
 - 2.20.3.3 The permission is valid for a period of six months after this permission must be re-applied for.
 - 2.20.3.4 Under no circumstances will permission for a further litter be granted. (04/17)

2.21 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/ daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given prior to the mating on the basis of health or genetic reasons to the benefit of the breed.

Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.

The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6 – 8.4 (Added 10/10, Amended EAP 12/14)

- 2.22 A member shall not permit any of that member's pure bred dogs to be mated to a dog of a different breed, to a cross bred dog, to a non ANKC registered dog of the same breed, or to a dog not on the ANKC Main Register without the prior approval of the Association.
- 2.23 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the

Codeof Ethics

separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.

Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. 08/11,04/13

- 2.24 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.
- 2.25 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.

Puppies are to be microchipped and vaccinated prior to leaving the Member's care.

- 2.26 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.27 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.28 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 2.29 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.30 A member **must** register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.31 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
 - 2.31.1 The breed characteristics;
 - 2.31.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
 - 2.31.3 Microchip number verification transfer is the responsibility of the vendor in accordance with R19.
 - 2.31.4 Responsible dog ownership information; and
 - 2.31.5 All documentation required by the member's Member Body, including
 - 2.31.5.1 a written receipt clearly stating whether the dog was sold with or without a Certificate of Registration (Main or Limited) "with or without papers" shall mean the Certificate of Registration
 - 2.31.5.2 any other conditions of sale and/or agreements (04/17)
- 2.32 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.33 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.34 A member shall not:
 - 2.34.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. [07/15]
 - 2.34.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

GENERAL

- 2.35 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:
 - 2.35.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
 - 2.35.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.36 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.
- 2.37 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:

"Please contact Dogs West on email: k9@dogswest.com to verify my membership."
