Clarification of ANKC Ltd Regulations

Regulations Part 5 – Conformation Shows Clause 1.2.1, Bred by Exhibitor
 14 currently reads:

Bred by Exhibitor -14 - For dogs aged six months and over. The exhibit must be owned and handled by the breeder of record. The exhibit must be handled throughout the breed classes, all group and general specials classes by the owner or part owner of the prefix under which the exhibit was originally registered.

Clarification:

If an exhibit is entered in class 14, it must be handled by the owner/breeder at all times right through to Best in Show. No one other than the breeder/owner may handle the exhibit at any stage of the show.

If 2 exhibits are owned/bred by a single person and the two exhibits are entered by the same person in class 14, the owner/breeder may determine which exhibit he/she will handle and the other exhibit would have to be withdrawn. If an exhibit is owned/bred by a partnership, then any member of the partnership may handle the exhibit through to Best in Show. To give an extreme example, if three exhibits of three different breeds are entered in class 14 and are owned/bred by the same couple and they all win Best in Group. Then for Best in Show, the couple could handle two of the exhibits and the third would have to be withdrawn.

President Report 2023



Thank you to the Vice President for presenting my Presidents Report tonight, apologies unable to attend meeting.

I congratulate the successful candidates in the Election for Vice President and Governing Council; I look forward to working with you over the next 12 months. My sincere thanks to all those who nominated and for the work you have done for Dogs West in the past.

My sincere thanks are also extended to all those Dogs West Members who have volunteered in any capacity over the past 12 months.

Dogs West is a Member organisation. It is a fact that, without the goodwill and support of our many Volunteers, Dogs West events and activities would simply not function.

The same applies to our many valued Affiliates who often struggle to run events and activities without the stress of securing volunteers to assist. I ask all Members to consider volunteering just once a year; volunteering can be a rewarding experience.

Volunteers at every level and all Members should be treated with respect and consideration. We are a small community and disharmony and intolerance does not foster a pleasant environment. We all need to consider carefully our interactions with each other and visitors to our grounds. It costs nothing but brings great reward in creating a pleasant place to be.

The two Open Days held this year were, once again, well attended and demonstrate the ongoing affection the general public have for dog ownership and our ability to provide a great atmosphere to the many thousands of Visitors who came along. Maintaining our profile to the wider public is important.

Dogs West has finished the year in a sound financial position, but faces challenges in relation to rising costs and falling income. Events have returned, with pleasing numbers in some disciplines, such as Scent Work and Tracking, but lower numbers than pre pandemic times for others, including Conformation. Lower entries are putting stress on Dogs West Affiliates who face higher costs for travel, in particular, but it also means less income for Dogs West to maintain our outstanding grounds and facilities.

This has meant a small rise in fees to counterbalance falling income, following the freeze on fee rises during the Pandemic . Our CEO is pursuing new sponsorship opportunities and ground use to broaden our income streams. There has been no advice from the landowner of the corner lot on Ranford and Warton Roads regarding the timing of future development; so the finalisation of the road surfacing and parking on the southern side of the main arena remains outstanding. This improvement is dependent on the construction of the new entry access as part of the development.

As I write this the Department of Local Government, Sport and Cultural Industries has just opened the consultation period on the Guidelines that will underpin the Regulations to be put into place under the Amendment to the Dog Act (Stop Puppy Farming) Bill that was passed in Parliament in December 2021.

This will drive the most significant change to the Regulations under the Dog Act in Western Australia since it began.

Dogs West will provide a response to this extensive survey and I urge Members to provide feedback. It should be noted that submissions can be made via email or online, and may be confined to relevant areas only.

Areas of significance for Dogs West Members include Sterilisation of Dogs, Dog Supply Approval for those involved in Rescue, and Approval To Breed.

The Sterilisation of Dogs and the Approval to Breed are of most concern and are interlinked. Many submissions and presentations were made before the Stop Puppy Farming Bill went to Parliament, on these matters, including presentations to the relevant Ministers.

The comments in the consultation remain of concern because they indicate that each Local Government will control these two important areas of the Regulations, and there is no mention of consistency across the sector, nor of the standards to be met to achieve an approval.

Dogs West will be exploring ways to find out more and will keep Members informed.

In closing I wish to thank the CEO, Marzel and all her Team, for a year of outstanding support for our Members and for being adaptable during changes over the last twelve months. It has been a steep learning curve for our new CEO who has just completed 12 months in her role, and has met many challenges and knowledge gaps with determination and flair. Congratulations to all.

And thank you everyone for being here this evening.

CEO Report 2023



At the last AGM, I had been here for less than 2 weeks. I was unsure what this dog world truly entailed, and I can say unequivocally that it has blown me away. Dogs West's activities, processes and Rules and Regulations are so expansive and diverse. It has been a whirl wind of learning and growth for

me. I have a few people to thank but I will leave that to the end.

Operationally, the Administration has been focused on building the best foundation possible for future organisational growth. The areas and key successes are as follows:

Compliance:

- Fair Work / Human Resources review. Contracts and workplace policies renewed
- Work Safe review. Review conducted. Actions currently in process.
- Governance. Process Audit. Improved processes implemented.
- Rules and Regulation Review. Commenced.

Business Systems:

- Online systems. Reviewed, various product solutions explored. Sharepoint (document sharing) in early phases of implementation. Other online tools to be presented to Governing Council over the next quarter.
- Customer Learning. Website quoting open.
- Volunteer and Club Learning. Website and Sharepoint solutions currently being reviewed.
- New electronic voting system implemented. 57% increase in votes from the previous year.

Other areas:

- Sponsorship review. Corporate sponsorship avenues are ongoing.
- Communication strategy revamped. 2 monthly e-newsletters and regular social media presence has commenced. Greater presence at the Royal Show to occur in 2023.
- Member culture. Raising awareness of behaviour standards through promotion and member discussions.
- Budget forecasting reviews. Six monthly budget reviews, commencing this year.

There is also a large amount of activity that happens outside of Administration from judges and stewards training to numerous State, National and flagship events. These will be covered in the Pillar Annual Reports which we will place on the website for those who want to read further.

I would have to say the National Agility Trial was a highlight for me, but I have enjoyed watching and learning more about the various disciplines offered in Western Australia.

Everything that was achieved would not have been possible without the contribution and support by firstly the Dogs West staff (Ian NcNiell, Kylie Halton, Nicquelle Rhodes, Samara Stables, Michelle Mathews, Vanessa Guidera, Anne Howell, Caroline Shaw and Bevan George). I thank the staff's efforts, patience and adaptability to tackling things a little differently.

I also thank the Executive and Finance Committee members (Heather Jones, Josh Griffiths and Cathy Storrs) for guidance and advice. I thank all the Pillar Chairs for their commitment to the organization making sure our Dogs West volunteers are supported and continue to engage, learn and grow. And as Pam outlined in her report, our volunteers are the backbone to all Dogs West activities.

Now for my final two thank you. I thank the President, Pam Campbell and Vice President, Des Kehoe who have invested into my development, always being available when needed and focusing on solutions first. Pam is a strong advocate for Western Australian interests at the national level, always balanced and calm. Des is a font of knowledge and an asset to Dogs West. Executive will not be the same without you.

I would like to acknowledge those from Governing Council that are retiring from their positions, Julia Logan and Jeni Sach. Thank you for your contributions. It has been a pleasure working with you both.

The bad weather and heavy rain during the week leading up to the National, saw Ron and Allan having to change their runs on a daily basis, as is usual in the area where the National was being held as the river levels can rise quite rapidly overnight. Both judges took this into account and with their Run Managers made the necessary changes to ensure the safety of the dogs and everyone involved.

We had 27 dogs entered, with 26 started. Some dogs failed the tests set by the judges over the first two days and so there were 11 dogs on Sunday going into run 7 and 8 dogs going into the last run, run 8.

Based on the book of the same name, written by the Australian novelist Craig Silvey. RUNT is about an adopted stray dog and a family trying to save their farm.


It features agility competitions in various settings and one of these will be filmed under our very own Pavilion!

STORY DOGS: A VOLUNTEER OPPORTUNITY



Story Dogs is on a mission to foster a secure, enjoyable, and supportive environment for primary school children requiring assistance with literacy. Through a unique approach of pairing children with dogs, this program harnesses the incredible outcomes derived from the accepting, loving nature of these animals. By reading to a friendly and calm dog, children experience a transformation—relaxing, opening up, trying harder, and finding joy in the process.

To contribute to the growth, learning, and confidence-building of children, Story Dogs invites individuals and their canine companions to become volunteers. The following are the nine essential steps to embark on this rewarding journey:

- 1. **Dog Eligibility:** Your dog should be at least one year old, and if adopted or rescued, you must have lived with it for a minimum of 6 months.
- **2. Registration:** Ensure your dog is registered with the local council, providing necessary proof.
- **3. Vaccination:** Present proof of your dog's vaccinations, a positive titer test is also acceptable.
- 4. Dog Team Assessment: Both you and your dog must pass the Story Dogs Team Assessment, which involves practicing the tasks outlined in the Volunteer Information Pack. An accreditation session with the Dog Team Assessor will be organised upon your confidence in meeting all nine requirements.
- 5. Health Check: A recent vet health check within the last 3 months or a Story Dogs vet health check is required.
- 6. Working with Children Check: Due to working with children, obtain a Working with Children check.

- 7. **Training Course:** Attend a full-day training course covering the Story Dogs program, volunteer expectations, session running guidelines, and information on facilitating children's reading development.
- 8. **In-School Training:** Gain practical experience by observing an experienced Story Dogs session at a local school.
- **9. Sponsorship:** With assistance from Story Dogs, find a sponsor for you and your dog using the Sponsor Invitation Pack.

Story Dogs is also actively seeking individuals interested in taking on roles as organizers, go-getters, and supporters. Providing mentorship and training, the organization values those who can support groups, approximately 10 Volunteer Dog Teams, or individuals looking to initiate new Story Dogs chapters in their regions. Code of Ethics HM MEMBERS' CODE OF ETHICS (latest amendment March 2023)

HM1 ACKNOWLEDGMENT

Each person, when signing an application for membership or renewal of membership of the Canine Association of Western Australia agrees to the following:

- to be bound by the ANKC Ltd regulations and rules
- to be bound by the Constitution, Rules and Regulations of the Association
- to be bound by the Association's Code of Ethics
- To allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. 04/17
- 1.2 Each member by signing any document shall be certifying that the information contained therein is true and correct.
- 1.3 A Member shall not forge, falsify or misrepresent the signature of another Member or person on any document relating to the activities of Dogs West or the Australian National Kennel Council Ltd. (05/21)

HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- 2.2 A member shall not engage in any behaviour that is contrary to the standards accepted by the community.

Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.

 Bullying is defined as repeated inappropriate behaviour direct or indirect, whether verbal, gesture, physical or otherwise, conducted by one person or persons against another person or persons.

This includes, but is not limited to:

- Cyber bullying placing an offensive or hurtful public message, image
 or statement on a social network site or other public forum where that
 message, image or statement can be viewed and/or repeated by other
 people will be regarded as bullying behaviour.
- Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
- Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. (07/15)
- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times.

This includes but is not limited to:

- Littering
- Damage
- Unacceptable behaviour
- Bullying
- 2.4 A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 2.5 A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 2.6 A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. 08/11

- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. **08/11**
- 2.8 Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- 2.9 Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
- 2.10 A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code. 2.10.1

During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.

- 2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. (04/17)w
- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community.

When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.

- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not dispose of dogs owned or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt. (04/20)
- 2.16 A member shall display good sportsmanship and conduct at all times so as to reflect credit upon themselves, the ANKC Ltd and the member's Member Body. (08/22)
- 2.17 A member shall at all times comply with all relevant consumer laws and regulations, both State and Federal. (08/22) (03/23)

BREEDING

- 2.18 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.19 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. (08/14)
- 2.20 A member shall not breed a bitch causing it to whelp **more than twice in any** eighteen month period (11/22)

HM MEMBERS' CODE OF ETHICS (latest amendment March 2023) Code of Ethics

2.21 Number of Litters

- 2.21.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
- 2.21.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch. (2/23)
- 2.22 Maximum Breeding Age

2.22.1 A member shall not mate a bitch over the age of seven (7) years. Note: after the bitch's seventh birthday. (07/18)

- 2.22.2 Extenuating Circumstances
- 2.22.2.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
 - a veterinary certification of fitness for further breeding issued in the last 30 days
 - the positive identification of the bitch microchip
 - reasons for the need for a litter from a bitch of this age
- 2.22.2.2 The member must have obtained written permission PRIOR to mating the bitch
- 2.22.2.3 The permission is valid for a period of six months after this permission must be re-applied for.
- 2.22.2.4 Under no circumstances will permission for a further litter be granted. (04/17) (11/22)
- 2.23 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/ daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given <u>prior to the mating</u> on the basis of health or genetic reasons to the benefit of the breed. Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.

The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6 - 8.4 (10/10) (12/14)

- 2.24 A member shall not permit any of that members' ANKC Pure Bred Registered dogs, without prior approval from the Association, to be used in any mating which would result in a litter being ineligible for registration on the ANKC Register. This includes
 - 2.24.1 To a dog of a different breed
 - 2.24.2 To a cross bred dog
 - 2.24.3 to a non ANKC registered dog of the same breed or
 - 2.24.4 to a dog not on the ANKC Main Register
 - 2.24.5 a mating not in compliance with R2.1. (04/21)
- 2.25 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.

Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. (08/11) (04/13)

- 2.26 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.
- 2.27 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.

Puppies are to be microchipped and vaccinated prior to leaving the Member's care.

- 2.28 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.29 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.30 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.

- 2.31 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.32 A member **must** register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.33 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
 - 2.33.1 The breed characteristics;
 - 2.33.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
 - 2.33.3 Microchip number verification transfer is the responsibility of the vendor in accordance with R19.
 - 2.33.4 Responsible dog ownership information; and
 - 2.33.5 All documentation required by the member's Member Body, including-
 - 2.33.5.1 a written receipt clearly stating whether, in accordance with R11.1, the dog is to be transferred to the purchaser or a Non-Transfer Agreement executed.(05/22)
 - 2.33.5.2 any other conditions of sale and/or agreements (04/17)
- 2.34 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.35 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.36 A member shall not:
 - 2.36.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. (07/15)
 - 2.36.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

GENERAL

- $2.37\$ A member who provides or makes available a dog for use in a film,
 - advertisement, promotion, or any media or public display must ensure that:
 - 2.37.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
 - 2.37.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.38 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.
- 2.39 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:

"Please contact Dogs West on email: <u>k9@dogswest.com</u> to verify my membership."

- 2.40 A member shall not use or cause to displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. (06/20)
- 2.41 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. (06/20)
