## **Amended Dogs West Regulations**

- **THAT** CAWA Regulation R11 be amended to read:

### **R11 TRANSFERS**

- 11.1 All applications to transfer a dog must be submitted on the Association's form.
- 11.2 A seller shall be responsible for, when selling or disposing of a dog in any way, submission to the Association of within 90 days of
  - a) transfer ownership of the dog to the new owner; or
  - b) a Non-Transfer Agreement, on the approved form.
- 11.3 A dog subject to a Non-Transfer agreement shall not be transferred to any other party while an agreement is in effect. A Non-Transfer Agreement can only be cancelled on written request from all parties.
- 11.4 Transfers shall be signed by all registered owners unless a signatory authority is lodged with the Association.
- 11.5 No dog will be transferred to any person normally resident outside Australia unless an Export Pedigree has been applied for.
- 11.6 An unbroken line of ownership must be established by the submission of a signed transfer on each occasion that a registered dog is transferred. Where this line is broken, and a signed transfer cannot be obtained, administrative officer may accept a statutory declaration as proof of transfer.
- 11.7 The vendor shall be responsible for the completion of the transfer form, including the name and address of the person to whom the dog is being transferred, and the date of transfer.
- 11.8 It is an offence to sign a blank transfer form, or to show an Australian address on a transfer form for a person normally resident outside Australia.
- 11.9 No dog shall be transferred while any registered owner is currently suspended or disqualified Effective 1<sup>st</sup> October 2021.

- **THAT** CAWA Regulation Section A be amended by the addition of:

A5.9 Document, Application, Form  
Any reference in these and all other Association regulations, rules or policies to 'Document', 'Application', or 'Form' shall mean any piece of written, printed, or electronic matter, submitted to or issued by Dogs West, that provides information or evidence or that serves as an official request, application, record, response or submission.

- **THAT**, CAWA Regulations Section A be amended by the addition of:

- A5.10 Applications
- 5.10.1 All applications must be
    - (a) signed by all parties
    - (b) completed in full
    - (c) accompanied by the prescribed fee and by such other information and documents as may be required by the Constitution or the Regulations and
    - (d) lodged with the Chief Executive.
  - 5.10.2 Where any document issued by the Chief Executive or an Affiliate Member is lost, stolen or destroyed Council or the Affiliate Member may require any Member requesting replacement of the document to provide a Statutory Declaration evidencing the loss, theft or destruction and the Association or Affiliate may charge a fee for replacement.

- **THAT** CAWA Regulation HM1 be amended to read:

### **HM1 ACKNOWLEDGMENT**

- 1.1 Each person, when signing an application for membership or renewal of membership Dogs West agrees to the following:
  - to be bound by the ANKC Ltd regulations and rules
  - to be bound by the Constitution, Rules and Regulations of the Association

- to be bound by the Association's Code of Ethics
- to allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. 04/17
- 1.2 Each member by signing any document shall be certifying that the information contained therein is true and correct.
- 1.3 A Member shall not forge, falsify or misrepresent the signature of another Member or person on any document relating to the activities of Dogs West or the Australian National Kennel Council Ltd.

- **THAT** CAWA Regulations Section A be amended by the addition of:

### **A87 Education**

- 87.1 Plagiarism, Self-Plagiarism And Collusion  
A member shall not initiate or engage in plagiarism or collusion.  
Plagiarism is the representation of another's language, thoughts, ideas, or expressions as one's own original work. Examples of forms of plagiarism include:
- the verbatim (word for word) copying of another's work without appropriate and correctly presented acknowledgement;
  - the close paraphrasing of another's work by simply changing a few words or altering the order of presentation, with or without appropriate and correctly presented acknowledgement;
  - unacknowledged quotation of phrases from another's work;
  - the presentation of another's concept as one's own;
- Collusion (including contract cheating) is where work is prepared or produced with or by others but then submitted for assessment as if it were the product of individual effort. Unless specifically instructed otherwise, all submissions for assessment must be a member's own work.

- **THAT** CAWA Regulations Section A be amended by the addition of:

- A87.2 All items submitted by a member for assessment must contain the following declaration:  
Declaration  
By submitting this work, I declare it is completely my own work, and any material taken from another source has been cited.

# IMPORTANT NOTICE TO MEMBERS

## New requirement to transfer dogs upon change of ownership

In January 2021 the Board of the ANKC resolved via electronic motion that:

***'Effective 1 March 2021, it is the breeder/seller's responsibility, when disposing of a puppy/dog, to transfer the ownership of the puppy/dog to the new owner.'***

Dogs West was one of the few State Member Bodies that did not already have such a Regulation in place.

From 1 October 2021 Dogs West members must do one of the following when disposing of a dog:

- Transfer the dog to the new owner by completing and submitting the paperwork to Dogs West to effect the transfer of the dog,

or

- If there is an agreement between the parties that the dog remains in the current owners names, lodge a Non Transfer Agreement with Dogs West that is signed by all parties.

### **In both instances it is the responsibility of a Member when disposing of a dog to complete and submit the required paperwork.**

Governing Council resolved to make the Non Transfer Agreement an option for our Members, not all States have this option. The form will be available on the Dogs West website.

It was also resolved by Governing Council that, to enable our members to be compliant with the ANKC Regulation, the following amendment be made to R11 of Dogs West Regulations. The following amendments will apply from October 1 2021.

#### **R11 TRANSFERS**

- 11.1 All applications to transfer a dog must be submitted on the Association's form.

A seller shall be responsible to transfer the ownership of a dog, when a dog is **disposed**.

**A completed transfer of ownership form to the new owner must be submitted by the seller to the Association within 90 days of change of ownership. Where it is agreed by the parties that the dog is to remain in the registered ownership of the seller, then a Non-Transfer agreement must be submitted by the seller on the approved form within 90 days of change of ownership.**

- 11.2 A dog subject to a Non-Transfer agreement shall not be transferred to any other party while an agreement is in effect.

A Non-Transfer Agreement can only be cancelled on written request from all parties.

- 11.3 Transfers shall be signed by all registered owners unless a signatory authority is lodged with the Association.

- 11.4 No dog will be transferred to any person normally resident outside Australia unless an Export Pedigree **Application is submitted**.

- 11.5 An unbroken line of ownership must be established by the submission of a signed transfer on each occasion that a registered dog is transferred.

Where this line is broken, and a signed transfer cannot be obtained, the Administrative Officer may accept a statutory declaration as proof of transfer.

- 11.6. The **seller** shall be responsible for the completion and submission of the transfer form, including the name and address of the person to whom the dog is being transferred, and the date of transfer.

- 11.7 It is an offence to sign a blank transfer form, or to show an Australian address on a transfer form for a person normally resident outside Australia.

- 11.8. No dog shall be transferred while any registered owner is currently suspended, **terminated** or disqualified.

The lodgement fee for a Non Transfer Agreement will be \$45 – the same as the cost of a transfer.

In consideration of the change, Governing Council resolved that the \$60 Litter Record Fee will no longer apply from 1 October 2021.

The purpose behind the change is to have consistency across the ANKC Ltd Registration system for all State Member Bodies, and to have the Register correctly reflect the ownership of all dogs.

## NEW FEATURE IN 'ONLINE SERVICES' PORTAL

### **What are the improvements?**

Commencing Friday July 30th, 2021, Dogs West Members can log into the 'Online Services' portal and view a list of dogs currently registered in their name. If a dog listed has passed away, you can select the dog and mark it as 'deceased'. This will update the records in ANKC National database and remove the dog from the list of animals currently owned by you.

### **Why did we make the change?**

DOGS West, together with the other ANKC Member Bodies, are currently working towards replacing the existing database. In preparation for the transfer of data, we are actively creating ways to help clean existing data.

### **Is there a cost to change a record?**

There is NO charge to change the record of your dog to deceased. The feature is free of charge.

## SUMMARY OF THE ANKC LTD SPECIAL BOARD MEETING HELD VIA ZOOM VIDEO CONFERENCING ON 19<sup>th</sup> JUNE, 2021

At the June 2021 ANKC Ltd Special Board meeting, Directors resolved/considered the following:

### 1. Ehrlichiosis in Dogs

It was RESOLVED to publish on the ANKC and all Member Body websites and social media pages an article authored by Dr Karen Hedberg BVSc, Chairperson of the ANKC Canine Health & Wellbeing Committee, regarding an emerging disease – Ehrlichiosis in Dogs.

### 2. \* ANKC Ltd Canine Hip & Elbow Dysplasia Report Submission Form: Amendment

It was RESOLVED to that the ANKC Ltd Canine Hip & Elbow Dysplasia Report Submission Form be amended to include a check box confirming the dog has not previously been scored under the ANKC Ltd Canine Hip & Elbow Dysplasia Scheme.

### 3. \* ANKC Ltd Regulations Part 6 – The Register & Registration

It was RESOLVED that Regulations Part 6 – The Register & Registration, Section 8 – Breeding, Clause 8.17.2 be amended with the addition of dot point (g) to read:

- 8.17.2 *Once agreed they should develop a proposed breed survey rationale, with questions that must be answered and a proposed date of commencement (after the Breed Survey (BS) is completed). The following outline should be followed to develop the required breed survey:*
- a. *Description of the condition;*
  - b. *Severity of the condition designated as a problem in the breed;*
  - c. *Mode of inheritance if known;*
  - d. *Percentage (with known DNA testable conditions) of affected carrier and normal in the current population. These can be obtained from the major testing facilities both locally and overseas;*
  - e. *Desired breeding strategy for DNA testable diseases - with the desired strategy being to not produce any more affected progeny and at the same time keep as diverse a gene pool as possible.*
  - f. *For non DNA testable diseases the breeding aim is to lower the incidence of severe inherited disease across the breed as a whole.*
  - g. *And are of sufficient maturity from which to be bred.***

Note: This amendment to the regulations will be effective 1 January 2022.

### 4. \* ANKC Ltd Regulations Part 6 – The Register & Registration

It was RESOLVED that Regulations Part 6 – The Register & Registration, Section 8 – Breeding, Clause 8.17.4 be amended to read:

- 8.17.4 *Once the final wording has been accepted, the BS made available to all owners and breeders of the breed involved in each State/Territory journal, website and social media pages in a timely manner.*

Note: This amendment to the regulations will be effective 1 January 2022.

### 5. \* ANKC Ltd Regulations Part 6 – The Register & Registration

It was RESOLVED that ANKC allow inter-variety breeding of Peruvian Hairless Dogs in accordance with FCI regulations effective from 1 July 2021.

As a result Regulations Part 6 – The Register & Registration, Section 9 – Breed Varieties – Judging & Interbreeding, Clause 9.14 will be amended to read:

#### 9.14 Peruvian Hairless Dog – Small: Peruvian Hairless Dog – Medium: Peruvian Hairless Dog – Large (Amended 10/13 – 5.6.4)

- a. Judged separately with each variety receiving separate Challenge Certificates.
- b. Inter variety breeding is approved, only bred to the nearest variety in size – or risk of whelping problems.
- c. Reclassified on size type is permitted as follows:
  - 1) Where a Peruvian Hairless Dog fails to reach or develops beyond the height for which it is registered then, up to twelve months of age, it may be measured and re-registered within the actual size that the dog has achieved.
  - 2) Three [3] licensed judges selected by ANKC Ltd shall carry out the measuring.
  - 3) The three [3] judges shall be residents of the same State or Territory as that in, which the dog resides.
  - 4) The measuring device used shall be that approved by ANKC Ltd.
  - 5) Any challenge points awarded to the dog under the size of its original registration shall be cancelled, upon re-registration. **(10/07, 6.2.7)**
- d. LONG COAT Long coat to long coat will always give long coat (as a single recessive gene).
- e. COLOUR Never breed Merle to Merle – ¼ will be homozygote for lethal/health defects, such as deafness

Note: This amendment to the regulations will be effective 1 July 2021.

### 6. \* ANKC Ltd Regulations Part 8 – Member Bodies & Membership

It was RESOLVED that Regulations Part 8-Member Bodies & Membership, Section 6: Stationery/Certificates be amended to read:-





"I certify that this exhibit has not within the said period of three weeks been in premises affected with Distemper, Canine Hepatitis, Parvo Virus or any other contagious disease and is currently vaccinated in accordance with current World Small Animal Veterinary Association International Vaccination Committee (WSAVA IVC) policies." (10/09, 8.10) (Amended 10/15, 6.1.8) (Amended 06/21, 4.2)

Note: This amendment to the regulations will be effective 1 January 2022.

## 7. \* ANKC Ltd Regulations Part 3N – Regulations for the Conduct of Scent Work Trials/Judges Training Scheme

It was RESOLVED that Regulations 3N – Regulations for the Conduct of Scent Work Trials/Judges Training Scheme, Clause 1.1 be amended to read:

1.1 Responsibility for the accreditation of Scent Work Judges will rest with:

- (a) the ANKC National Scent Work Committee, for a period of twelve months (1) year from the date of implementation;
- (b) thereafter the relevant Member Body through its Scent Work Sub-Committee.

Note: This amendment to the regulations will be effective 1 July 2021.

\* **New or Amended regulations, policy statements, procedures, publications and listings will be made available from the ANKC Ltd website.**

# ANKC LTD SURVEY - AFGHAN HOUND OWNERS

In accordance with Regulations Part 6 – The Register & Registrations Section 1.11 an online survey is now available from the link provided below where ANKC is seeking feedback from owners of Afghan Hounds regarding proposed minimum breeding age requirements. Details of the proposal and rationale are noted below for reference:

## PROPOSAL:

The ANKC Ltd and the ANKC Ltd National Canine Health and Wellbeing Committee recommend that:

The ANKC Ltd have resolved to conduct a Survey of all Afghan Hound owners recommending that Litter Registration Limitations are to be applied to litters mated on or after 1st June 2022:-

The Minimum Breeding Age for Afghan bitches is 24 months at the time of mating (unless a veterinary certificate is produced stating that for health reasons the bitch should be mated before 24 months)

If litter registration limitations are approved for the Minimum Breeding Age for Afghan Hound bitches, breeders of litters whelped on or after 1st June, 2022, will be required to comply with the requirements as a prerequisite to registration of any litter on the ANKC Ltd Main Register. Litters which do not meet the above requirements will only be able to be placed on the Limited Register and will be flagged not to be upgraded.

A majority of registered owners within the breed and responding to this survey must be in favour before approval is given by the ANKC Ltd.

## RATIONALE:

*The National Afghan Hound Breed Council does not presently have any rule regarding the minimum breeding age for Afghan Hound bitches so is governed by ANKC Regulations Part 6 Clause 8.2 which states 'the minimum breeding age for bitches across all breeds is 12 months at the time of mating.'*

*It is considered that an Afghan Hound bitch:*

- *is not of adequate maturity to be bred at 12 months of age as she is still developing at this age*
- *the Afghan bitch's health is of prime concern to responsible breeders*

## Conformation Judges Training Program - TRAINEE JUDGES' COURSE 2022

### Eligibility:

1. The applicant must be at least 18 years of age.
2. Have been a member of the ANKC Member Body for a minimum period of eight (8) years during the ten (10) years immediately prior to the date of the application.
  - (a) The ANKC Member Body may consider an application from a person transferring from another State or Territory of Australia or overseas, who can provide evidence that their canine experience extends over a minimum period of eight (8) years, during the ten (10) years immediately prior to the date of the application, as a member of the canine controlling body in the State, Territory or country of prior residence immediately prior to the date of transferring.
  - (b) The ANKC Member Body may consider for approval an application from an applicant over the age of eighteen (18) years who otherwise would not qualify under Clause 4(a)& (b) below. Such applicant must demonstrate active involvement in canine activity for the minimum period as a handler for parents and others in ordinary classes and supply evidence as required by 4.(c) below and such other evidence of experience as the ANKC Member Body may require.
3. Provide sufficient evidence of experience as a breeder, exhibitor and steward in canine activity, as outlined hereunder, or meet the criteria as approved by the ANKC and affiliated National Breed Council.

### The applicant must:-

- (a) Have bred at least three (3) litters under their own or shared prefix.
- (b) Have bred at least two (2) Champions under their own or shared prefix. Applicants can define any other success in the Show Ring (i.e. any major awards or achievements by dogs bred and/or exhibited by the applicant).

- (c) Dispensation may be granted from (a) on production of evidence from the applicant that they reside in an area that prohibits the breeding of dogs by State or Local Authority law.
- (d) **Have successfully completed the CAWA's Stewards Course.** Should an Applicant not have completed the Steward's Course when applying to join the scheme, the course must be completed before the Rules and Regulations lecture is conducted.
- (e) In the two years prior to application, completed the minimum stewarding experience as laid out in Regulation F4.1.1.6(c)
- (f) In the two years prior to application, have demonstrated a history of ongoing commitment to dog showing through the various aspects of the sport such as Show Management and other aspects of Affiliate and Show Administration. This commitment is to continue for the duration of training.

Applicants must be approved by the relevant committee of the ANKC member body in the state or territory of residence. In WA, this will be on the recommendation of the Conformation Judges Training Working Party.

These may be obtained from the Canine Association of Western Australia inc. office or website. Please send a stamped, addressed envelope if you require an application form to be posted out.

Applications must be made to the Chief Executive of the Canine Association of Western Australia Inc. on the prescribed form, accompanied by the designated fee (\$71.00) and all supporting documentation MUST be included.

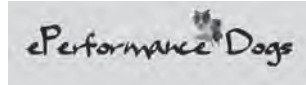

# SCENT WORK – AUSTRALIA'S NEWEST ANKC RECOGNISED SPORT

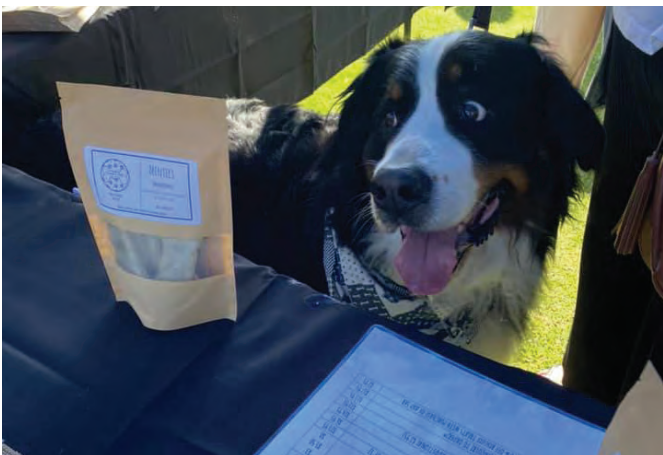
accessories stalls; food trucks; and even a doggie photo booth!

# Code of Ethics

MEMBERS' CODE OF ETHICS  
(latest amendment May 2021)

## SECTION H - CODES OF ETHICS

### HM MEMBERS' CODE OF ETHICS (effective 1 March 2008)

#### HM1 ACKNOWLEDGMENT

- 1.1 Each person, when signing an application for membership or renewal of membership of the Canine Association of Western Australia agrees to the following:
  - to be bound by the ANKC Ltd regulations and rules
  - to be bound by the Constitution, Rules and Regulations of the Association
  - to be bound by the Association's Code of Ethics
  - To allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. 04/17
- 1.2 Each member by signing any document shall be certifying that the information contained therein is true and correct.
- 1.3 A Member shall not forge, falsify or misrepresent the signature of another Member or person on any document relating to the activities of Dogs West or the Australian National Kennel Council Ltd. (05/21)

#### HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- 2.2 A member shall not engage in any behaviour that is contrary to the standards accepted by the community. Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.
  - Bullying is defined as repeated inappropriate behaviour direct or indirect, whether verbal, gesture, physical or otherwise, conducted by one person or persons against another person or persons. This includes, but is not limited to:
    - Cyber bullying – placing an offensive or hurtful public message, image or statement on a social network site or other public forum where that message, image or statement can be viewed and/or repeated by other people will be regarded as bullying behaviour.
    - Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
    - Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. (07/15)
- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times. This includes but is not limited to:
  - Littering
  - Damage
  - Unacceptable behaviour
  - Bullying
- 2.4 A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 2.5 A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 2.6 A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. 08/11

- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. 08/11
- 2.8 Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.
- 2.9 Members shall ensure that all dogs under their control are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required. A member shall not knowingly allow any dogs under their care to roam at large.
  - 2.10 A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code.
    - 2.10.1 During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.
    - 2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. 04/17
- 2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.
- 2.12 A member shall take all appropriate lawful measures to assist a dog in distress.
- 2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community. When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.
- 2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.
- 2.15 A member shall not surrender dogs owned, in the care of or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt (04/20)

#### BREEDING

- 2.16 A member shall breed primarily for the purpose of improving the quality and / or working ability of the breed in accordance with the breed standard, and not specifically for the pet or commercial market. A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member.
- 2.17 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. 08/14
- 2.18 A member shall not breed a bitch causing it to whelp
  - **more than twice in any eighteen month period** without the prior approval of the member's Member Body. (07/16)





- 2.19 Number of Litters
- 2.19.1 A member shall not breed a bitch causing it to whelp more than five (5) times.
- 2.19.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
- 2.19.3 Extenuating circumstances
- 2.19.3.1 A member may apply to Dogs West for permission for a sixth (6<sup>th</sup>) litter.  
The application is to include:
- a veterinary certification of fitness for further breeding issued in the last 30 days
  - the positive identification of the bitch – microchip
  - reasons for the need for a sixth litter
- 2.19.3.2 The member must have obtained written permission for the sixth (6<sup>th</sup>) litter PRIOR to mating the bitch
- 2.19.3.3 The permission is valid for a period of six months – after this permission must be re-applied for.
- 2.19.3.4 Under no circumstances will the registration of a seventh (7) litter be permitted. (04/17)
- 2.20 Maximum Breeding Age
- 2.20.1 A member shall not mate a bitch over the age of seven (7) years.  
Note: after the bitch's seventh birthday. (07/18)
- 2.20.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch.
- 2.20.3 Extenuating Circumstances
- 2.20.3.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:
- a veterinary certification of fitness for further breeding issued in the last 30 days
  - the positive identification of the bitch – microchip
  - reasons for the need for a litter from a bitch of this age
- 2.20.3.2 The member must have obtained written permission PRIOR to mating the bitch
- 2.20.3.3 The permission is valid for a period of six months – after this permission must be re-applied for.
- 2.20.3.4 Under no circumstances will permission for a further litter be granted. (04/17)
- 2.21 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given prior to the mating on the basis of health or genetic reasons to the benefit of the breed.  
Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.  
The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6 – 8.4 (Added 10/10, Amended EAP 12/14)
- 2.22 A member shall not permit any of that members' ANKC Registered dogs, without prior approval from the Association, to be used in any mating which would result in a litter being ineligible for registration on the ANKC Register. This includes
- 2.22.1 To a dog of a different breed
- 2.22.2 To a cross bred dog
- 2.22.3 to a non ANKC registered dog of the same breed or
- 2.22.4 to a dog not on the ANKC Main Register
- 2.22.5 a mating not in compliance with R2.1. 02/21
- 2.23 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.  
Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. 08/11, 04/13
- 2.24 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.
- 2.25 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.  
Puppies are to be microchipped and vaccinated prior to leaving the Member's care.
- 2.26 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.
- 2.27 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 2.28 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 2.29 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 2.30 A member **must** register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.
- 2.31 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
- 2.31.1 The breed characteristics;
- 2.31.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus
- 2.31.3 Microchip number verification – transfer is the responsibility of the vendor in accordance with R19.
- 2.31.4 Responsible dog ownership information; and
- 2.31.5 All documentation required by the member's Member Body, including
- 2.31.5.1 a written receipt clearly stating whether the dog was sold with or without a Certificate of Registration (Main or Limited) - "with or without papers" shall mean the Certificate of Registration
- 2.31.5.2 any other conditions of sale and/or agreements (04/17)
- 2.32 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 2.33 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 2.34 A member shall not:
- 2.34.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. [07/15]
- 2.34.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.
- ### GENERAL
- 2.35 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:
- 2.35.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
- 2.35.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 2.36 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.
- 2.37 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:  
"Please contact Dogs West on email: [k9@dogswest.com](mailto:k9@dogswest.com) to verify my membership."
- 2.38 A member shall not use or cause to be displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. (06/20)
- 2.39 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. (06/20)
