Updated Agility Rules - Effective 1 January 2026

Regulations Part 3L - Regulations for the conduct of Lure Coursing Competitions (Encompassing Lure Coursing Sanctioned Events & Lure Pursuit Sanctioned Events) Judges Training & Assessment Program - Effective 1 January 2026

The amended Regulations Part 3L - Regulations for the conduct of Lure Coursing Competitions (Encompassing Lure Coursing Sanctioned Events & Lure Pursuit Sanctioned Events) Judges Training & Assessment Program is available from our website at: <https://dogsaustralia.org.au/members/rule-regulations/regulations/> and marked as effective from 1 January 2026.

Rules for the Conduct of Lure Coursing Competitions (Encompassing Lure Coursing Sanctioned Events & Lure Pursuit Sanctioned Events) - Effective 1 January 2026.

The Coursing Ability stream (the stream for Non-Sighthounds) is being renamed to the Lure Pursuit stream. References to Non-Sighthounds coursing are being replaced with references to pursuit of the lure.

All titles for Non-Sighthounds will become Lure Pursuit titles (for example, Junior Pursuit, Lure Pursuit, Lure Pursuit Advanced etc). No changes to existing title criteria are being made. For example, a Lure Pursuit Excellent title will have the same requirements as a Coursing Ability Excellent title.

A new Lure Pursuit prefix Champion title will be offered. As is standard practice, an additional qualification after the rules commence will be necessary to be eligible for the Lure Pursuit Champion title.

The course length range for Lure Pursuit has been adjusted to 500-1000 metres. It is still up to the affiliate club running the event whether it wants to set a shorter course for Lure Pursuit, noting that the Sighthound range remains 600-1000 metres.

Some additional adjustments will be made to the rules to reflect the changes, including guidance for judges.

Please note these arrangements do not commence until 1 January 2026.

Amended Dogs West Regulations

CAWA Regulation A85 amended to read:

A85 DOGS ON THE ASSOCIATION'S GROUNDS

85.5.1 That puppies aged between 8 weeks and under 3 calendar months be permitted to use the Dogs West grounds for restricted training purposes.

85.5.2 That the use of the grounds be limited to organised classes only, conducted under strict biosecurity conditions - including use of enclosed rooms, agreed cleaning protocols, and no free access to the grassed areas.

85.5.3 That organisations offered the opportunity to conduct these restricted classes must be affiliated with Dogs West.

CAWA Regulation B16.10 amended to read:

16.10 (a) Qualifications of exhibits for entry to a Retrieving or Field Trial shall be as at the date of the Trial. 06/15

(b) Qualifications of exhibits for entry to a Tracking or Track and Search Trial shall be as at the closing time and date of the trial. Any requested upgrades prior to the event should be at the affiliates discretion in consultation with the Judge.

CAWA Regulation HSS 8 deleted in its entirety and remaining clauses renumbered accordingly.

~~HSS8— Gate and Ring Stewards shall not exhibit under any judge that they may be officiating for at that show, to be read in conjunction with C12:~~

CAWA Regulation B21.1 deleted in its entirety. Effective immediately

~~B21— CATALOGUES (11/23)~~

~~21.1— Catalogues are not to be made available prior to one hour before the advertised start time of a conformation show. Royal shows and cluster shows' catalogues may be released one hour prior to the first day or the first show.~~

PROTESTS & DISPUTES TRIBUNAL

18/11/2025

Ms M Oliveira (STAUNCHBLUES) is found GUILTY of a breach of HM2.22.

Minimum penalty, as prescribed under Dogs West Regulation A58.5, be imposed -a fine of \$500, plus \$100 per puppy in the litter, totalling \$600 and the puppy be placed on the Limited Register, flagged never to be upgraded.

16/12/2025

Ms S Wightman, as the owner of CH. FANTASTIKROT SWEET LITTLE LIES Reg No 6100140958, is found guilty of a breach of Regulation A44.3.

The penalty is a 4 Month Suspension, \$200 fine, and CH. FANTASTIKROT SWEET LITTLE LIES Reg No 6100140958 must pass a temperament test to be reinstated.

Ms S Wightman is found guilty of a breach of HM2.17 and a penalty of \$500.00 be imposed.

06/01/2026

Mrs K Seymour is found guilty of a breach of HM2.33 in respect of clauses 2.33.3 & 2.33.5.1.

The penalty is that a formal reprimand be issued and a fine of \$100.

Each person, when signing an application for membership or renewal of membership of the Canine Association of Western Australia agrees to the following:

- to be bound by the ANKC Ltd regulations and rules
 - to be bound by the Constitution, Rules and Regulations of the Association
 - to be bound by the Association's Code of Ethics
 - To allow the inspection of the member's premises as required for the purpose of investigating compliance with the regulations and the code of ethics. **04/17**
- 1.2 Each member by signing any document shall be certifying that the information contained therein is true and correct.
- 1.3 A Member shall not forge, falsify or misrepresent the signature of another Member or person on any document relating to the activities of Dogs West or the Australian National Kennel Council Ltd. **(05/21)**

HM2 CODE OF CONDUCT

- 2.1 A member shall not knowingly or recklessly misrepresent the ANKC or the member's Member Body.
- 2.2 A member shall not engage in any behaviour that is contrary to the standards accepted by the community. Members and others defined in HM2.3 will not engage in bullying or harassing or unacceptable behaviours towards other members, staff, volunteers or contractors or disorderly conduct.
- 2.2.1 Bullying is defined as repeated inappropriate behaviour direct or indirect, whether verbal, gesture, physical or otherwise, conducted by one person or persons against another person or persons. This includes, but is not limited to:
- 2.2.2 Cyber bullying – placing an offensive or hurtful public message, image or statement on a social network site or other public forum where that message, image or statement can be viewed and/or repeated by other people will be regarded as bullying behaviour.
- 2.2.3 Unacceptable behaviour is defined as any behaviour that a reasonable person, having regard for the circumstances, would see as victimising, humiliating, undermining or threatening.
- 2.2.4 Disorderly conduct is defined as disturbing the peace or endangering the morals, health or safety of others. **12/24**
- 2.2.5 A member shall not, on more than 2 occasions in an 18 month period, lodge complaints that are found by the Investigations Committee to be Vexatious or Frivolous, as outlined in Regulation A22.
- 2.2.6 A member shall not engage in unreasonable conduct with staff or volunteers, as outlined in Regulation A23(06/25)
- 2.3 Members shall be responsible for any and all actions by themselves, their family members or guests when attending sanctioned events and their interactions with other members at all times. This includes but is not limited to:
- 2.3.1 Littering
- 2.3.2 Damage
- 2.3.3 Unacceptable behaviour
- 2.3.4 Bullying
- 2.4 A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 2.5 A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 2.6 A member shall at all times and in all forums, including at DogsWest approved events, in dealings in wider forums including chat lists on the internet and in all other communications, conduct themselves in a manner respectful of the reputation of the ANKC and DogsWest members, judges, staff and officials. **08/11**
- 2.7 An exhibitor is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting that exhibitor or exhibitor's exhibits. This includes social networking sites, email, and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to the appropriate member body and disciplinary action may be taken against the exhibitor. **08/11**
- 2.8 Members shall constantly strive to improve their knowledge of their chosen breed or breeds, and their knowledge of the requirements for the care, welfare and betterment of dogs.

2.9 Members shall ensure that all dogs under their care are properly controlled, housed, fed, watered, exercised and receive veterinary care as and when required.

It is an offence for a member to allow any dogs under their care to;

2.9.1 suffer neglect due to lack of any or all of the following

- adequate food,
- water,
- shelter,
- exercise,
- grooming,
- veterinary care,
- other basic requirements

2.9.2 knowingly roam at large.(06/25)

2.10 A member shall permit any person authorised in writing by the Administrative Officer, following a resolution of the Governing Council, to enter and inspect any premises owned or occupied by the member for the purpose of investigating compliance with HM2.9 of this Code. **2.10.1**

During the conduct of the inspection the member will permit the authorised person to record any necessary details by tape, video or photographs.

2.10.2 Failure to permit the inspection of the premises without reasonable cause shall result in suspension of the member's privileges until that inspection has taken place. **04/17**

2.11 The registered owner of a dog shall remain ultimately responsible for said dog, including if left in the care of another person.

2.12 A member shall take all appropriate lawful measures to assist a dog in distress.

2.13 A member shall positively enhance the reputation of dog breeders and owners by ensuring that dogs owned by the member are not a danger or nuisance to the community. When the dog is away from home a member shall ensure that it is kept on a leash and/or effective control at all times.

2.14 A member shall not participate in nor support any activity that involves cruelty or damage to animals, excluding legal hunting activities.

2.15 A member shall not dispose of dogs owned or bred by the member to a pound or animal refuge. Breed Rescue Clubs run by ANKC Ltd members are exempt. **(04/20)**

2.16 A member shall display good sportsmanship and conduct at all times so as to reflect credit upon themselves, the ANKC Ltd and the member's Member Body. **(08/22)**

2.17 A Member shall comply with the requirements of WA Consumer Protection. **(08/22)**

BREEDING

2.18 A member shall breed primarily for the purpose of improving and / or maintaining the health, quality and / or working ability of the breed, and for breed preservation, in accordance with the breed standard.

A member retains the right of free trade, to advertise directly and sell dogs not kept for line maintenance purposes by that member. **12/24**

2.19 A member shall not breed with a bitch unless the bitch has reached adequate maturity for that breed as determined by the member's Member Body. The minimum breeding age for bitches across all breeds is twelve (12) months at the time of mating. Except in extenuating circumstances or with the approval of Governing Council prior to the mating, a member shall not breed from any bitch causing it to be mated before it is twelve months of age. **08/14**

2.20 A member shall not breed a bitch causing it to whelp **more than twice in any eighteen month period (11/22)**

2.21 Number of Litters

2.21.1 A member shall not breed a bitch causing it to whelp more than five (5) times.

2.21.2 It is the responsibility of the current registered owner to verify the number of litters a bitch may have had prior to their ownership of said bitch. **(03/23)**



2.22 Maximum Breeding Age

2.22.1 A member shall not mate a bitch over the age of seven (7) years.

Note: after the bitch's seventh birthday. **(07/18)**

2.22.2 Extenuating Circumstances

2.22.2.1 A member may apply to Dogs West for permission to mate a bitch over seven years of age. The application is to include:

- a veterinary certification of fitness for further breeding issued in the last **30** days
- the positive identification of the bitch – microchip
- reasons for the need for a litter from a bitch of this age

2.22.2.2 The member must have obtained written permission **PRIOR** to mating the bitch

2.22.2.3 The permission is valid for a period of six months – after this permission must be re-applied for.

2.22.2.4 Under no circumstances will permission for a further litter be granted. **(04/17) (11/22)**

2.23 First generation (father/daughter, mother/son, brother/sister) matings are not permitted. ANKC Ltd Member Bodies will not register the progeny of father/daughter, mother/son, brother/sister matings on the Main Register unless application was made to the Member Body and approval was given prior to the mating on the basis of health or genetic reasons to the benefit of the breed.

Any breach of this regulation will constitute an offence by the member(s) who are the owners of the sire and the dam of the litter.

The progeny resulting from such a breach will be registered on the Limited Register and endorsed 'never to be upgraded' and any further penalties as may be determined by the member's Member Body. Refer ANKC Part 6 – 8.4 **(Added 10/10, Amended EAP 12/14)**

2.24 A member shall not permit any of that members' ANKC Pure Bred Registered dogs, without prior approval from the Association, to be used in any mating which would result in a litter being ineligible for registration on the ANKC Register. This includes

2.24.1 To a dog of a different breed

2.24.2 To a cross bred dog

2.24.3 to a non ANKC registered dog of the same breed or

2.24.4 to a dog not on the ANKC Main Register

2.24.5 a mating not in compliance with R2.1. **(04/21)**

2.25 Breaches of Regulations 2.18, 2.19, 2.20, 2.21 and 2.22 are considered to be a serious breach of the Code of Ethics. For that reason, offences in relation to each of the separate regulations will be considered cumulatively in applying penalties to the Registered Breeder/Member.

Any puppies not registered on the Main Register are to be registered on the Limited Register with the endorsement 'Not to be upgraded to Main register'. **08/11, 04/13**

2.26 A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Code of Practice for Hereditary Diseases.

2.27 A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.

Puppies are to be microchipped and vaccinated prior to leaving the Member's care.

2.28 A member shall not export a puppy under the age of eleven [11] weeks, or such greater age permitted under the livestock import requirements of the country to which the puppy is being exported.

2.29 A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.

2.30 A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.

2.31 A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.

2.32 A member **must** register all puppies bred by that member that are living at the date of registration. Such registration must include all living puppies from the litter on the one litter registration application form and must be applied for within six [6] months of the date of whelping.

2.33 A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:

2.33.1 The breed characteristics;

2.33.2 Current Vaccination certificate signed by a Veterinary Surgeon evidencing that the dog has been immunised against Canine Distemper, Hepatitis and Parvo Virus

2.33.3 Microchip number verification – transfer is the responsibility of the vendor in accordance with R19.

2.33.4 Responsible dog ownership information; and

2.33.5 All documentation required by the member's Member Body, including-

2.33.5.1 a written receipt clearly stating whether, in accordance with R11.1, the dog is to be transferred to the purchaser or a Non-Transfer Agreement executed. **(05/22)**

2.33.5.2 any other conditions of sale and/or agreements **(04/17)**

2.34 A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.

2.35 A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.

2.36 A member shall not:

2.36.1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. Nor shall a member's dog/s be advertised, displayed or sold on commission by a commercial dog wholesaler or retail pet dealer. **[07/15]**

2.36.2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

GENERAL

2.37 A member who provides or makes available a dog for use in a film, advertisement, promotion, or any media or public display must ensure that:

2.37.1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and

2.37.2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.

2.38 A member shall oppose all activities which involve cruelty to dogs or in which dogs inflict damage on other dogs or other animals excluding the hunting of vermin.

2.39 A breeder must include their ANKC Ltd Member Body Membership Number in any advertisement for puppies whatever the media and all members must include the following wording in their advertisements:

"Please contact Dogs West on email: k9@dogswest.com to verify my membership."

2.40 A member shall not use or cause to be displayed, in any form or in any media, their Dogs West membership number in relation to any progeny, real or planned, from a dog not on the ANKC MAIN register. **(06/20)**

2.41 A member shall not declare, make or infer any relationship, in any form or in any media, between their membership of The Association, The Association and any dog not eligible for entry onto an ANKC register. **(06/20)**
