Microchip Register	records microchip numbers implanted in a

Multi Breed Club	an affiliate that caters for more than one
	specified breed of registered dogs but not all
	breeds in a group as defined by the ANKC.
Neuter Registered Dog	a dog registered on the Main Register may be
	registered as a neutered dog if sterilised.
Open Show	a conformation event judged by trainee or Open
	Show judges where no championship points are
