### **Amended Dogs West Regulations**

#### **F14 APPLICATIONS AND RENEWALS**

CAWA Regulation F14.2 be amended to read:

14.2 Application for renewal of Trainee Judge status shall be made on the appropriate form accompanied by relevant fee and submitted annually to the Canine Association of Western Australia (Dogs West office) not later than 1st December or where this falls on a weekend or public holiday, by close of business on the next working day. (02/19)

14.2.1 In the event that the application is not received by the required date, an additional late fee, as prescribed in the list of charges, will accompany the application for renewal up until 10<sup>th</sup> December each year.

CAWA Regulation A38 amended to read:

#### **A38 CONFIDENTIALITY OBLIGATIONS**

##### **38.1 Confidentiality Obligations - Governing Councillors**

All members of the Governing Council are required to maintain confidentiality pursuant to the terms of the Confidentiality Agreement executed by each member of the Governing Council on their appointment to that office.

If any Councillor breaches the terms of the Confidentiality Agreement then it shall be within the Governing Council's complete discretion to determine the appropriate course of action in response to that breach, including but not limited to calling a Special General Meeting to vote on the disqualification of the Councillor pursuant to Section 15.9 of the Constitution. **(08/20)**

##### **38.2 Confidentiality Obligations – Governance Panels**

All members of a Governance Panel are required to maintain confidentiality pursuant to the terms of the Confidentiality Agreement executed by each member of the Governance Panel on their appointment to that Governance Panel. Should a member of a Governance Panel refuse to sign the Confidentiality Agreement, then they shall be deemed to have refused their appointment to that Governance Panel and they shall be removed with immediate effect from that appointment. If any member of a Governance Panel breaches the terms of the Confidentiality Agreement then it shall be within the Governing Council's complete discretion to determine the appropriate course of action in response to that breach, including but not limited to revoking or terminating the appointment of the member to the Governance Panel. **(08/24)**

##### **38.3 Confidentiality Obligations – Conformation Trainee Judges**

All Conformation Trainee Judges are required to maintain confidentiality pursuant to the terms of the Confidentiality Agreement executed by each Trainee Judge on their application to be a trainee judge. Should a Conformation Trainee Judge refuse to sign the Confidentiality Agreement, then they shall be deemed to have withdrawn their application to become a Trainee Judge and will immediately be ineligible to continue as a Conformation Trainee Judge. If any Conformation Trainee Judge breaches the terms of the Confidentiality Agreement then it shall be within the Governing Council's complete discretion to determine the appropriate course of action in response to that breach, including but not limited to revoking the appointment of the Trainee Judge. (01/25)

38.4 Confidentiality Obligations will apply to any person who assists in any role in the Conformation Judges Training Scheme.

CAWA Regulation A19.4 amended to read:

**A19 APPLICATION FOR AFFILIATION**

- 19.4 Each application to become an affiliate of the Association shall be made in writing, signed by the applicant's Secretary and lodged with the Administrative Officer of the Association, and shall be accompanied by:
- 19.4.1 The name of the club.
  - 19.4.2 The aims of the club.
  - 19.4.3 The affiliation fee as laid down in the scale of charges.
  - 19.4.4 The formal acceptance of the CAWA Basic Constitution for Affiliated Clubs and submitted as detailed in the Basic Constitution together with the proposed domestic rules.
  - 19.4.5 A complete list of the names and addresses of all financial members of the club and the name and registration number of one registered dog owned or part owned by each member.
  - 19.4.6 Ordinary members of the Breed or Multi-breed clubs must be the registered owner of a breed (s) that the club represents.
  - 19.4.7 A statement of the office bearers positions and number of places on the committee
  - 19.4.8 The names of the office bearers and members of the committee.
  - 19.4.9 A statement of the club's financial affairs.
  - 19.4.10 A list of club activities held during the last twelve months.
  - 19.4.11 Other information as Council may require.
  - 19.4.12 An undertaking, in writing signed by the President and Secretary of the applicant club, that upon its admission as an affiliate, the club will annually thereafter immediately following each Annual General Meeting of the club furnish to the Association a certified copy of the club's Balance Sheet for the preceding year, copy of any report of the club's activities, current financial membership and names and addresses of current elected office bearers and committee members.

CAWA Regulation A39 be amended to read:

**A39 STATEMENT – RECORDING ANNOUNCEMENT**
